MEMORANDUM OF TRUST

THIS MEMORANDUM OF TRUST executed on this the 29th day of August 1989 is a summary of certain provisions contained in a trust agreement executed August 29, 1989 between GRACE F. BRANT, as Settlor, and HARRY F. WALLS III, as Trustee.

Said Trust provides in part as follows:

- 1. No party dealing with the Trustee in relation to the trust property in any manner whatsoever, and (without limiting the foregoing), no party to whom the property or any part of it or any interest in it shall be conveyed, contracted to be sold, leased or mortgaged by the Trustee, shall be obliged (a) to see to the application of any purchase money, rent or money borrowed or otherwise advanced on the property; (b) to see that the terms of the Trust Agreement have been complied with; (c) to inquire into the authority, necessity or expediency of any act of the Trustee; or (d) to be privileged to inquire into any of the terms of the Trust Agreement.
- the Trustee in relation to the trust property shall be conclusive evidence in favor of every person claiming any right, title or interest under the Trust (a) that at the time of its delivery the Trust created was in full force and effect; (b) that such instrument was executed in accordance with the terms and conditions of this Agreement and all its amendments, if any, and is binding upon all beneficiaries under it; (c) that the Trustee was duly authorized and empowered to execute and deliver such instrument; (d) if a conveyance has been made by a successor or successors in trust, that such successor or successors have been appointed properly and are vested fully with all the title, estate, rights, powers, duties and obligations of its, his or their predecessor in trust.
