(herein referred to as GRANTEES for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate situated in Shelby County, Alabama to-wit:

Part of the NW 1/4 of NE 1/4 of Section 10, Township 22 South, Range 4 West, Shelby County, Alabama, being more particularly described as follows: From the Southwest corner of said NW 1/4 of NE 1/4 of said Section 10, run in a Northerly direction along the West line of said 1/4 1/4 section for a distance of 124.04 feet to the point of beginning; thence continue in a Northerly direction along last mentioned course for a distance of 115.96 feet to an existing nail; thence turn an angle to the right of 89° 34' and run in an Easterly direction for a distance of 283.28 feet to an existing iron pin; thence turn an angle to the right of 90° 25' 08" and run in a Southerly direction for a distance of 156.14 feet to an existing iron pin; thence turn an angle to the right of 83° 55' 52" and run in a Southwesterly direction for a distance of 148 feet to an existing iron pin; thence turn an angle to the right of 27° 37' and run in a Northwesterly direction for a distance of 146.36 feet, more or less, to the point of beginning.
