KNOW ALL MEN BY THESE PRESENTS,

That in consideration of One Dollar, (\$1.00), and other good and valuable consideration DOLLARS to the undersigned grantor or grantors in hand paid by the GRANTEES herein, the receipt whereof is acknowledged, we, David Miller and wife, Katherine Miller; Norma Vanderslice, an unmarried woman, Charles A. Miller and wife, Angela Miller (herein referred to as grantors) do grant, bargain, sell and convey unto

(herein referred to as GRANTEES for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate situated in Shelby County, Alabama to-wit:

Part of the NW 1/4 of NE 1/4 of Section 10, Township 22 South, Range 4 West, Shelby County, Alabama, being more particularly described as follows: From the Southwest corner of said NW 1/4 of NE 1/4, run in a Northerly direction along the West line of said 1/4 - 1/4 section for a distance of 124.04 feet to an existing iron pin; thence turn an angle to the right of 111° 32' and run in a Southeasterly direction for a distance of 146.36 feet to an existing iron pin; thence turn an angle to the left of 27° 37' and run in a Northeasterly direction for a distance of 164.89 feet to an existing iron pin; thence turn an angle to the right of 04° 07' 30" and run in an Easterly direction for a distance of 275.40 feet to an existing iron pin, being the point of beginning; thence turn an angle to the left of 91° 00' 28" and run in a Northerly direction for a distance of 147.29 feet to an existing iron pin; thence turn an angle to the left of 87° 28' 02" and run in a Westerly direction for a distance of 132.14 feet to an existing iron pin; thence turn an angle to the right of 90° 26' and run in a Northerly direction for a distance of 100.0 feet to an existing iron pin; thence turn an angle to the right of 89° 34' and run in an Easterly direction for a distance of 594.66 feet to an existing iron pin; thence turn an angle to the right and run in a Southerly direction for a distance of 212.33 feet, more or less, to an existing iron pin; thence turn an angle to the right and run in a Southwesterly direction for a distance of 457.19 feet, more or less, to the point of beginning.
