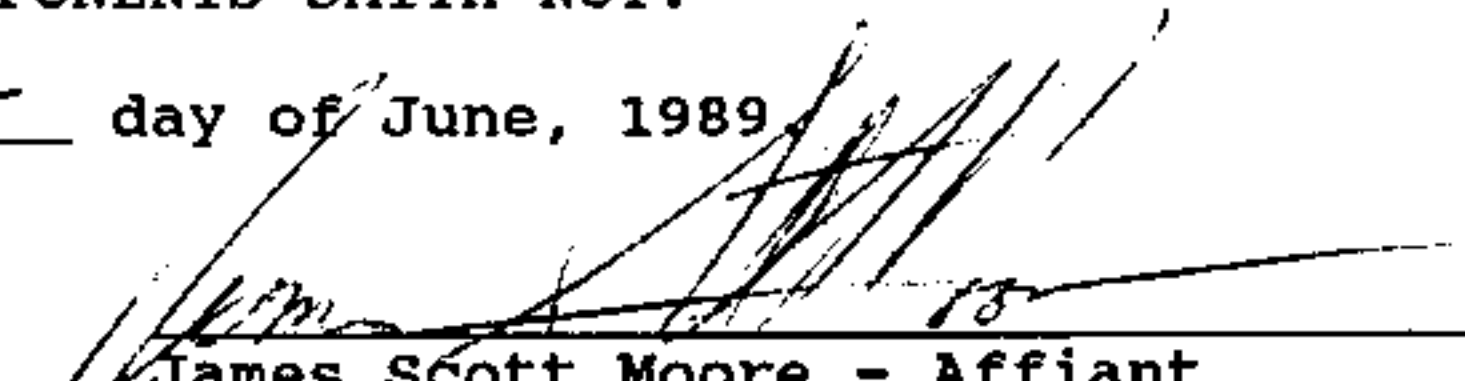

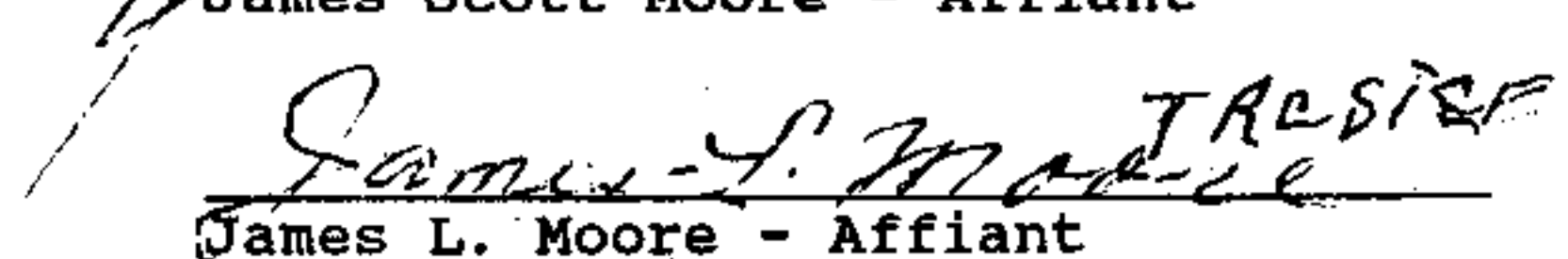
3. Doug Van Natter is the clerk of the Church.

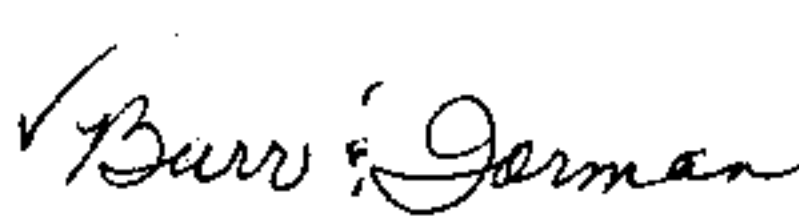
