CONVEYANCE OF REAL PROPERTY INTERESTS IN DISSOLUTION OF

WHEREAS, Dayton F. Hale, Sr., an individual, David G. McGiffert, an individual, Dayton F. Hale, Jr., an individual, Woodrow Hobson, Jr., an individual, Karen J. Colwell, an individual, and Thomas W. Daniel, Jr., an individual, constitute all of the shareholders of the said Alabama Basic Land Enterprises, Inc.; and

WHEREAS, Alabama Basic Land Enterprises, Inc. owns certain mineral rights, overriding royalty interests and other real property interests, which are due to be distributed to the shareholders of said corporation pursuant to dissolution of said corporation; and

WHEREAS, the resolution adopted by all shareholders of Alabama Basic Land Enterprises, Inc. at the shareholders' meeting held on the 23rd day of September, 1989, directs that, with respect to the distribution of such corporate assets, each shareholder receive from the corporation a deed or deeds conveying to such shareholder an undivided interest in each corporate asset in the same proportion to the shareholder's ownership in the shares of the corporation; and

KNOW ALL MEN BY THESE PRESENTS, That in consideration of the sum of One and No/100 (\$1.00) Dollar to the undersigned Grantor, Alabama Basic Land Enterprises, Inc., an Alabama corporation, in hand paid by the Grantees herein, the receipt whereof is acknowledged, and in consideration of the mutual benefits derived by the officers, directors and shareholders of Grantor in effecting the dissolution and distribution of the assets of Alabama Basic Land Enterprises, Inc., the said Grantor hereby grants, bargains, sells, conveys and quit claims an undivided 40.977% interest to Dayton F. Hale, Sr., an undivided 13.669% interest to David G. McGiffert, an undivided 9.153% interest to Dayton F. Hale, Jr., an undivided 13.669% interest to Woodrow Hobson, Jr., and an undivided 8.863% interest to Thomas W. Daniel, Jr. (hereinafter referred to as Grantees), in and to the following described real estate, situated in Shelby County, Alabama, to-wit:

This conveyance is made subject to all existing easements, rights of way, liens, leases and contracts, whether or not they are of record. Grantor makes no warranties of title, express or implied, however, Grantor conveys all warranties previously granted to it.
