CERTIFICATE OF INCORPORATION

WE HEREBY CERTIFY:

That a meeting of the worshipers and members of the church and congregation known as the River of Life Christian Center was duly and regularly held on October 11, 1989 in the church building of said church situated on the property at the intersection of State Highway No. 145 and County Highway 28 in the Kingdom Community of Shelby County, Alabama, which said church building is a place where said members and congregation meet for public worship; that said meeting was held to determine whether the church and congregation should be incorporated; and further, that said meeting was held for the purpose of electing trustees to take charge of all the property and estate, both real and personal, of said church and congregation, and to transact all affairs relative to the temporalities thereof, and thereby have trustees to promote and administer the causes, purposes, goals and objects of said church as a body corporate, all in conformity with Section 10-4-20, et seq, Code of Alabama (1975).

That due and regular notice of said meeting for the election of trustees and incorporation of said church was given by announcement from the pulpit on October 1, 1989 and October 8, 1989 at regular scheduled meetings of the congregation of the above said church.

That at the time and place so designated in the above said notices, to-wit, the 11th day of October, 1989 following the Wednesday evening service, in the church building, said members and worshipers present and entitled to vote, elected Steve Bingham, a member and voter of said church and congregation, as chairman and moderator of said meeting, and Doug Bulger, a member and voter of said church and congregation, as secretary of said meeting, and after determining the qualifications of the voters at said meeting, received and counted the vote at said meeting.

That a resolution was duly introduced, seconded and passed by a unanimous vote directing that said congregation should incorporate and it was determined by unanimous vote to incorporate said congregation pursuant to the laws of the State of Alabama, and in particular, Section 10-4-20, et seq, Code of Alabama, (1975).

That the name of the proposed corporation or incorporated church, as decided on at said meeting is River of Life Christian Center. That the principal place of worship of said corporation is presently to be located on the property wherein the church building is located, being the corner of State Highway No. 145 and County Highway No. 28, in the Kingdom Community in Shelby County, Alabama.

That the corporation may acquire, hold, administer, distribute or dispose of real and personal property, may take, receive and acquire property by gift, devise, or bequest and hold, own, administer, use, distribute and dispose of such

property for the advancement, promotion, extension or maintenance of such causes and objects as may be prescribed by the church as a body corporate, in conformity with all lawful conditions imposed by any donor, and may exercise such other powers as are incident to a private corporation. Further, all such powers may be exercised by such corporation in its own right or as trustee or as personal representative.

That the congregation decided on four trustees at said meeting, and their names are: Steve Bingham, Doug Bulger, Larry Guy, and Rex Horton, and their term of office was set at a term of 5 years, and until their successors are duly elected and qualified, and said trustees shall remain as trustees until their successors are so duly elected and qualified, and the trustees when acting in said capacity and a majority thereof, shall be empowered to act for and on behalf of said corporation as designated above.
