PARTIAL RELEASE AND AMENDMENT TO NOTE

KNOW ALL MEN BY THESE PRESENTS, That:

In consideration of One Dollar (\$1.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the undersigned First Commercial Bank, an Alabama banking corporation (the "Bank") does hereby release Sherwood J. Stamps from all obligations pursuant to that certain Promissory Note (the "Note") in the principal amount of One Hundred Thousand Ninety-one and 94/100 Dollars (\$100,091.94) dated March 30, 1987 executed by Charles A. J. Beavers, Jr. and Sherwood J. Stamps and that certain Purchase Money Mortgage and Security Agreement (the "Mortgage") recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Book 122, page 789, given to secure the Note.

The Bank does further hereby release, remise, quit claim, and convey unto Sherwood J. Stamps his undivided one-half (1/2) interest in and to the real property described in the Mortgage. Said undivided one-half (1/2) interest of Sherwood J. Stamps is hereby declared to be released from and free and clear of the Mortgage.

It is expressly understood and agreed that this release shall not in any manner affect the obligations of Charles A. J. Beavers, Jr. to the Bank pursuant to the Note and the Mortgage nor the lien of the Mortgage upon the remaining undivided one-half (1/2) interest of Charles A. J. Beavers, Jr. in the property described in the Mortgage.

The Bank hereby acknowledges receipt from Sherwood J. Stamps of the sum of Forty-four Thousand Thirty-eight and 09/100 Dollars (\$44,038.09) which has this date been applied to reduce the principal portion of the Note, thereby leaving a present outstanding principal balance owing under the Note of Forty-four Thousand Thirty-eight and 08/100 Dollars (\$44,038.08). The Bank also hereby acknowledges receipt from Sherwood J. Stamps of the sum of Three Hundred Forty-four and 77/100 Dollars (\$344.77) which has been applied this date toward the reduction of the accrued but unpaid interest on the outstanding principal balance and which represents one-half (one-half) of the accrued but unpaid interest.

The Note is hereby amended by changing the repayment schedule as follows:

- (a) From henceforth, payments shall be made on the last day of each month, commencing on the 31st day of October, 1989.
- (b) From henceforth, the monthly installments shall be reduced to the sum of Six Hundred Twenty-seven and 21/100 Dollars (\$627.21) each month, commencing on the 31st day of October, 1989.

- (c) All other provisions of the Note, except as modified herein, shall remain in full force and effect.
