The undersigned, desiring to organize a body corporate pursuant to Title 10-3A-1 et seq. Code of Alabama 1975, as amended, entitled The Alabama Non-Profit Corporation Act, and each of whom is over the age of nineteen (19) years, do make, sign and file these Articles of Incorporation as follows:

- 1. The name of the corporation shall be Meadowridge Homeowners Association, Inc.
- 2. The objects and purposes for which the corporation is formed are:

To promote and foster the interest and well being of the residents of the Meadowridge neighborhood.
