- 1. That the Mortgagor will promptly pay the principal of and interest on the indebtedness evidenced by the said note, at the times and in the manner therein provided. Privilege is reserved to pay the debt, in whole or in part, on any installment due date.
- 2. Together with and in addition to the monthly payments of principal and interest payable under the terms of the note secured hereby, the Mortgagor will pay to the Mortgagee, on the first day of each month until said note is fully paid, the following sums:

It this mortgage be foreclosed in Chancery, reasonable attorney's fees for foreclosing the same shall be paid out of the proceeds of the sale.

- (iv) whose family income exceeds 115\$ (100\$ in the case of family size of less than 3 persons) of applicable median family income (140\$ for a family) (120\$ in the case of family size of less than 3 persons in a targeted area residence), all as provided in Section 143(f) and (i)(2) of the internal Revenue Code; or
- (b) Borrower ("Mortgagor") fails to occupy the property described in the Mortgage without Lender's ("Mortgagee's") prior written consent; or
- (c) Borrower ("Mortgagor") omits or misrepresents a material fact in an application for this mortgage.
