KNOW ALL MEN BY THESE PRESENTS:

That for the purpose of forming a non-profit corporation under and pursuant to the provisions of Section 10-3-1 et seq. of the 1975 Code of Alabama, as last amended, and Section 501 (c) (3) of the Internal Revenue Service Code, the undersigned persons have associated themselves together and have agreed upon and adopted these Articles of Incorporation, the same to constitute and become a charter for carrying on the activities hereinafter specified upon the proper filing hereof pursuant to law.

ARTICLE I: NAME

The name of this corporation shall be the Historic Shelby Association.

LOCATION ARTICLE II:

The principal office of the corporation shall be located in Shelby, Shelby County, Alabama at Route 1, Box 3462, Shelby, Alabama, and the registered agent shall be Nancy W. Brasher at said address.

ARTICLE III: OBJECTIVES

The objectives of the corporation shall be:

A. To carry on and conduct those activities,

functions and programs designed to promote and develop the community of Shelby, Shelby County, Alabama, in general, and specifically the history and historical aspects thereof, and to otherwise encourage the renovation of historical structures, and to establish and construct museums and other structures of interest and importance to the Shelby Community and to otherwise encourage the participation in such activities, functions and programs by all interested persons, groups, governments, foundations or other organizations either political or private. Any monetary profits or other benefits which flow to member shall be merely incidental thereto.

To assure no person shall have pecuniary interest in operation of the corporation.

To do any and all such further acts authorized by law as may be necessary, convenient or expedient to accomplish the foregoing purposes or as are incidental thereto.

LIMITING OBJECTIVES ARTICLE IV:

- 1. This corporation shall not have or exercise any power or authority, either expressly, by interpretation, or by operation of law, nor shall it directly or indirectly engage in any activity that would prevent this corporation from qualifying (and continuing to qualify) as a corporation described in Section 501 (c) (3) of the Internal Revenue Code, as to preclude contributions to this corporation from being deductible for purposes of taxation.
- 2. No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation; nor shall it, in any manner, or to any extent, participate in, or intervene in (including the publishing or distributing of statements) any political campaign on behalf of any candidate for public office; nor shall it engage in any activities that are unlawful under the laws of the United States of America or the State of Alabama, or any other jurisdiction where such activities are carried on; nor shall it engage in transactions defined at the time as "prohibited" under Section 503 of the Internal Revenue Code.
- This corporation shall never be operated for the primary purpose of carrying on a trade or business for profit. Neither the whole, nor any part or portion, of the assets or net earnings of this corporation shall ever be organized or operated for purposes that are not exclusively religious, charitable, scientific, literary or educational within the meanor operated for purposes that are not exclusively religious, ing of Section 501 (c) (3) of the Internal Revenue Code.
- No compensation or payment shall ever be paid or made to any member, officer, director, trustee, incorporator or organizer of this corporation, or any contributor to it, compact except as a reasonable allowance for actual expenditures made or services actually rendered to or for this corporation; and neither the whole nor any part or portion of the assets or net earnings, current or accumulated, of this corporation shall ever be distributed to or divided among any such persons; provided, further, that neither the whole nor any part or portion of such assets or net earnings shall ever be sued for, accrue to, or inure to the benefit of any member or private individual within the meaning of Section 501 (c) (3) of the Internal Revenue Code.

ARTICLE V: MEMBERSHIP

The corporation shall have one class of members. There should be no limitation on the number of members except as provided for in the by-laws of the corporation. other qualifications, rights and duties of the members of said corporation shall be set out and established in the by-laws of the corporation.

- c. The voting members of the corporation shall have the authority to adopt such rules, by-laws and regulations for the governing of the corporation as they may deem necessary or expedient.
- p. The fiscal year of the corporation shall begin January 1 of each year and continue until December 31 of each year.
- E. In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations exempt as organizations described in Sections 501(c) (3) and 170(c) (2) of the Internal Revenue Code of 1986 or
