In consideration of \$17,000.00, receipt of which is acknowledged, The University of Alabama in Birmingham Medical and Educational Foundation, an Alabama non-profit corporation (herein called the "Foundation") does grant, bargain, sell, and convey to the City of Alabaster, Alabama, a municipal corporation, the following described real estate located in Shelby County, Alabama:

Commence at the northwest corner of Section 23, Township 21 south, Range 3 west, Alabaster, Shelby County, Alabama and run thence southerly along the west line of said Section 23 a distance of 51.62' to a point on the southerly right of way line of Shelby County Road No. 12 and the point of beginning of the property being described, thence continue along last described course a distance of 464.64' to a point on the northerly line of Lot 20, Block 5, Meadowlark Subdivision as recorded in the Office of the Judge of Probate of Shelby County, Alabama, thence turn a deflection angle of 87° 50' 59" to the left and run easterly along the north line of Lots 20, 21, and 22 of same said Meadowlark Subdivision a distance of 384.32' to a point, thence turn a deflection angle of 89° 58' 08" to the left and run northerly a distance of 464.56' to a point on the southerly right of way line of same said Shelby County Road No. 12, thence turn a deflection angle of 90° 04' 00" to the left and run westerly along said right of way line a distance of 402.00' to the point of beginning.
