4. Subsequent to the said incorporation, the shares of stock owned by Alton Dunaway, E. F. Dunaway and P.K. Hamilton, were purchased by Ramar Hamilton, and Ramar Hamilton is, therefore, the sole shareholder in Land Planning, Inc.
5. A copy of the written consent to dissolve the said Land Planning was executed by Ramar Hamilton on _____, 1989, and a state of intent to dissolve said corporation was executed on Dec. 27, _____, 1989.

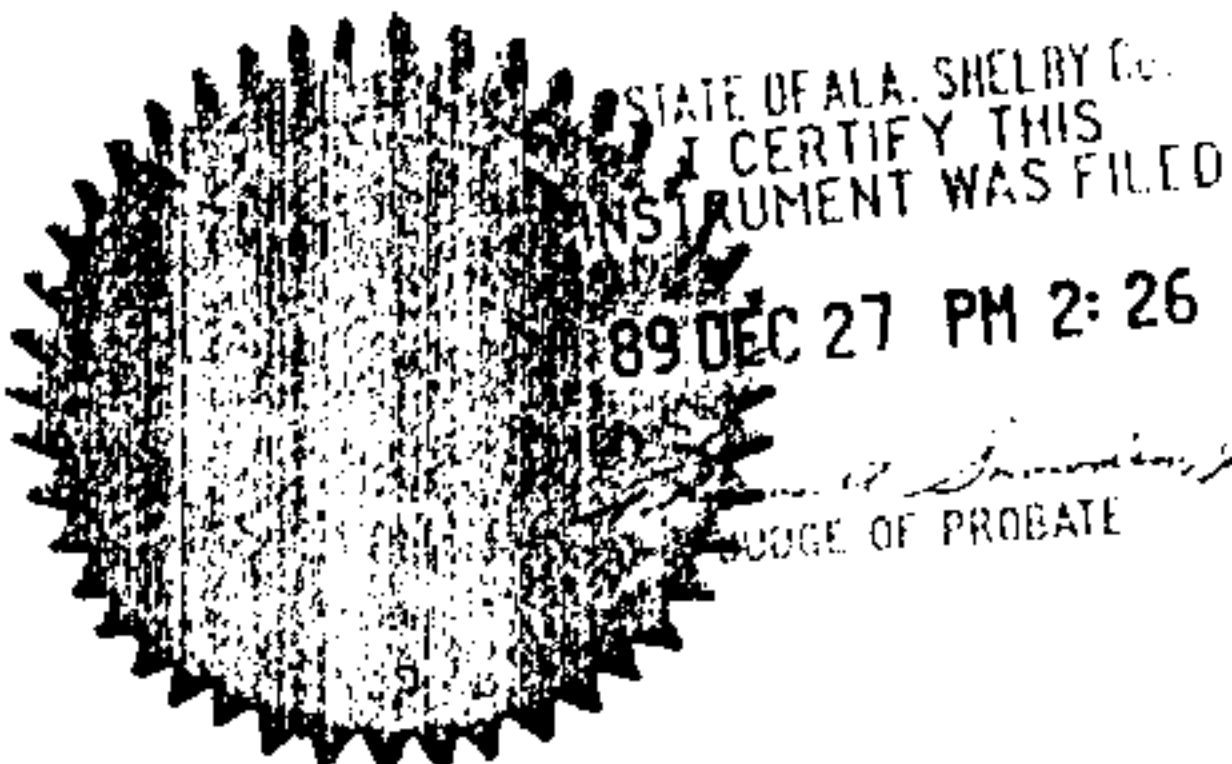
