MEMORANDUM OF LEASE

THIS LEASE dated the 15th day of September, 1989 by and between Service Station Holdings Inc., whose address is 200 Public Square, Cleveland, Ohio 44114-2375, hereinafter (whether one or more), called "Lessor," and BP Oil Company, an Ohio corporation, with its principal office at 200 Public Square, Cleveland, Ohio 44114-2375 hereinafter called "Lessee,"

WITNESSETH, that:

Lessor, in consideration of the sum of ONE DOLLAR (\$1.00) and other valuable consideration received by Lessor from Lessee, does hereby lease and let to Lessee, upon and subject to the covenants, terms, rentals and agreements set forth in a certain instrument of lease between Lessor and Lessee dated June 30, 1989, (herein called "Lease"), the premises (herein called the "Leased Premises") described in Exhibit "A" attached hereto and made a part hereof.

TO HAVE AND TO HOLD the same for a term of twenty (20) years commencing on the 1st day of July, 1989, and ending on the 30th day of June, 2009, unless sooner terminated or further extended as provided or permitted in said Lease. Lessee is granted by the terms of said Lease a continuing option of "First Refusal" to meet any bona fide offer received by Lessor from a third party to purchase or lease the Leased Premises and Lessee has the right to purchase or lease said premises on the same terms as contained in such offer. Lessee is further granted by said Lease the following options to extend the term thereof.

Two options of ten (10) years each

Lessor and Lessee agree that the description of the Leased Premises as contained in the Lease is hereby amended to substitute therefore the description of said premises as herein above set forth, and that each and every other provision, covenant and condition with respect to the rights and obligations of the parties hereto and the use and occupancy of the above described Leased Premises as set forth in said Lease shall remain in full force and effect without modification and are incorporated herein and made a part hereof by reference thereto as fully and effectively as if rewritten herein at length.

Situated in the City of Hoover, County of Shelby, State of Alabama; And

Commence at the NW corner of the NE 1/4 of the NW 1/4 of Section 29, Township 19 South, Range 2 West, run in an easterly direction along the north line of the NE 1/4 of the NW 1/4 for a distance of 950.19 feet to a point on the southeast right of way of Valleydale Road, said point being the point of beginning; thence continue along last described course for a distance of 383.43 feet; thence turn an angle to the right of 139 degrees 45 minutes 42 seconds and run in a southwesterly direction along the northwesterly line of Lots 6A, 5A & 4A of Wildwood Park as recorded in Map Book 3, Page 78 in the Office of the Judge of Probate Shelby County, Alabama for a distance of 524.20 feet; thence turn an angle to the right of 96 degrees 55 minutes 11 seconds and run in a northwesterly direction for a distance of 271.42 feet to a point on the southeasterly right of way of Valleydale Road; thence turn an angle to the right of 90 degrees 00 minutes and run in a northeasterly direction along the southeasterly right of way of Valleydale Road for a distance of 34.18 feet to the point of commencement of a curve to the left, said curve having a central angle of 1 degree 37 minutes 32 seconds and a radius of 5844.59 feet; thence run along the arc of said curve in a northeasterly direction along the southeast right of way of Valleydale Road for a distance of 165.82 feet to the point of beginning. Said parcel contains 91,951 square feet or 2.1109 acres.
