ARTICLE FOUR

POWERS

The componation shall have and may exemples in pursuit of its componate pumposes these powers and other such powers as are confirmed by the Alabama Business Componation Act and other laws of the State of Alabama:

- (a) To have and exercise all of the powers confirmed on corporations in the Alabama Business Corporations Act, and the restatement in this section of certain powers shall not be construed as an exclusion of any powers so conferred by the laws of Alabama or the United States of America or as a limitation on the exercise of all powers conferred by the Alabama Business Corporation Act.
- (b) To lend and bornow money in the corporate name upon notes, mortgages or other securities with or without security at the option of the corporation; to make, issue, purchase, acquire, hold, sell, exchange, pledge, hypothecate, or otherwise dispose of on deal in notes, acceptances, open accounts, montgages, or other evidence indebtedness in the obligations of any person, firm or corporation; to buy, sell, discount or otherwise deal in montgages, notes, deeds of thust or other securities on real and personal property, or other indebtedness or commercial paper. whether or not in the promotion of the corporate business; to borrow or raise monies from time to time. without limit as to amount; to execute, endonse and/or deliver as evidence of such bornowing all kinds of securities, including but without limiting the generalities thereof promissory notes, drafts, bills of exchange, bonds and debentures and other negotiable or nonnegotiable instruments and evidences of indebtedness.
- (c) To punchase, take, receive or otherwise acquire, hold, own, pledge, transfer or otherwise dispose of its own chares, with the right to punchase its own shares, whether direct or indirect, to the extent of its capital surplus available therefore, subject to the additional limitations provided for in Section 10-2A-22 of the Alabama Business Corporation Act. To make any quaranty or contract of quaranty or surety respecting stocks, debentures, dividends, securities, indebtedness, interest, contracts, leases, or other obligations created by any domestic or foreign corporations, associations, partnerships, individuals, firms or other entities.
- (d) To establish and to pay pensions and pension plans, profit sharing, stock options, stock purchases, stock benuses, retirement, benefit or incentive in compensation plans, trust and provisions for any or all of its directors, officers and employees and for any or all of the directors, officers, and employees of its subsidianies.
- (e) To provide insumance for the componation's benefit on the life of any of its directors, officers or employees. Or on

the life of any stockholder for the purpose of acquiring at his death shares of the corporation stock owned by a stockholder.


