- c) To transact any and all lawful business for which professional corporations may be incorporated under the Revised Alabama Professional Corporation Act.
- 4. Provisions for the regulation of the internal affairs of the professional corporation are:
 - a) No shareholder of the professional corporation shall have preemptive rights to purchase any shares of any issuance of the professional corporation.
 - b) The professional corporation shall have the right to purchase, take, receive, or otherwise acquire, hold, own, pledge and transfer or otherwise dispose of its own shares to qualified persons, to the extent of its unreserved and unrestricted capital surplus available therefor.
 - c) The Bylaws of the professional corporation shall be adopted by the shareholders. The power to alter, amend, or repeal the Bylaws or adopt new Bylaws shall be vested in the Board of Directors; provided, however, that the Board of Directors may not alter, amend, or repeal any bylaw establishing what constitutes a quorum at shareholders' meetings.

- 8. Any other provisions of the Articles of Professional Association which are not inconsistent with the changes made herein to a professional corporation are hereby reaffirmed.
