ARTICLES OF INCORPORATION

OF

The membership of Monte-Sil Baptist Church meeting in a Special Called Business Meeting on December 20th, 1989, did adopt, by unanimous vote, a resolution as follows:

1. Be it known, that the present Article os Incorporation are recorded in the Probate Office of Shelby County, Alabama in Corporation Book 9, at page 346-350;

2. Be it known, that the name of the corporation is Monte-Sil Baptist Church, Inc.;

3. Be it known, that on and after January 1, 1990, the name of the corporation shall be: Southside Baptist Church, Inc.; and

4. Be it known, that the present trustees, Larry Reeser, Lonnie Vickers and Jewel Crumpton, are authorized and directed to sign and file of record these Amended Articles Of Incorporation.

PREMISES CONSIDERED, Paragraph First of the Articles of Incorporation of Monte-Sil Baptist Church, Inc. is hereby amended to read: The name selected for the corporation is Southside Baptist Church, Inc.


