## SUBORDINATION OF MINERAL RIGHTS TO SURFACE RIGHTS

WHEREAS, William F. Batson, a single man

(hereinafter sometimes referred to as Grantors) are the present owners of an undivided interest in mineral rights in and to the hereinafter described parcel of land and
