CONSENT FINAL ORDER AND JUDGMENT

This adversary proceeding came on for trial on October 24, 1989. Present were John E. Medaris, Esquire, attorney for the Plaintiff; and Richard K. Mauk, Esquire, attorney for the Debtor/Defendant. Counsel made known to the court that they had arrived at a settlement of their differences subject to this court's approval, and the court now approves the settlement which is contained in the terms of this Order.

Counsel have agreed for this bankruptcy court to enter this final judgment and consent to its jurisdiction.

It is therefore ORDERED, ADJUDGED AND DECREED as follows:

1. That the Plaintiff, Frances McCrea, have and recover of the Debtor/Defendant, Ronald Edward Brown, the sum of Twenty Three Thousand Four Hundred Twenty Six Dollars (\$23,426.00) plus One Hundred Twenty Dollars (\$120.00) costs, for which execution may issue. This is a NON-DISCHARGEABLE debt and is EXCEPTED from the discharge granted to Ronald Edward Brown on April 18, 1989 (Proceeding Number 13 in the main bankruptcy file number 89-02896).

2. Plaintiff shall have the right of all legal process for the full satisfaction and enforcement of this judgment.
