## AMENDMENT TO ARTICLES OF INCORPORATION OF HABITAT FOR HUMANITY, INC.

TO THE HONORABLE JUDGE OF PROBATE OF SHELBY COUNTY, ALABAMA

This is to certify the Board of Directors of Habitat for Humanity, Inc. has amended the Articles of Incorporation so that the name shall be changed to:

MONTEVALLO AREA HABITAT FOR HUMANITY, INC.

The Board of Directors of Habitat for Humanity, Inc. has also amended the Articles of Incorporation located in Book 039, Page 91 to add the following Eleventh Article:

ELEVENTH: Anything contained in these Articles of Incorporation to the contrary notwithstanding, the Corporation shall not carry on or otherwise engage in any activities not permitted to be carried on or engaged in by (i) a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code, as amended, or any corresponding section of any future tax code; (ii) a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code, as amended, or any corresponding section of any future tax code; or (iii) a corporation organized and existing under the Alabama Nonprofit Corporation Code.

The Board of Directors of Habitat for Humanity, Inc. has also amended the Articles of Incorporation located in Book 039, Page 91 to delete the NINTH article and include the following in its place:

NINTH: In the event of the dissolution and liquidation of this Corporation, to the extent allowed or permitted under applicable laws, the property and assets of the Corporation shall be, as determined by the Board of Directors, distributed to or sold and the proceeds of such sales distributed to (i) Habitat for Humanity International, Inc., a Georgia non-profit corporation and a corporation exempt from taxation under Section 501(c)(3) of the Internal Revenue Code, as amended or (ii) any other organization(s) organized and operating for the same purposes for which the Corporation is organized and operating or any organization(s), corporation(s), fund(s), or foundation(s) organized and

operating exclusively for religious, charitable, scientific, literary, education, or other purposes permitted by Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, all of which such organizations, corporations, funds, or foundations shall be exempt under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended. In the event that any assets are not disposed of in accordance with the provisions of these Articles of Incorporation or that the Corporation shall fail to act within a reasonable time in the manner provided in these Articles of Incorporation, the Court of Shelby County shall, upon the application of one or more persons having a real interest in the Corporation or its assets, make such distribution(s) as provided in these Articles of Incorporation.

The Board of Directors of Habitat for Humanity, Inc. has also amended the Articles of Incorporation located in Book 039, Page 91 to delete the THIRD article and include the following in its place:

THIRD: The Corporation is organized pursuant to the Alabama Nonprofit Corporation Code (Section 10-3A-1 through 10-3A-225 of the Code of Alabama, 1975) and is a non-profit corporation as described in Section 501(c)(3) of the Internal Revenue Code of 1986, as amended.


