

ARTICLES OF INCORPORATION OF ROOFING MEMERANE SYSTEMS, INC.

The undersigned, acting as incorporator of a corporation under the laws of the State of Alabama, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is ROOFING MEMBRANE SYSTEMS, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are:

- (a) To assemble, construct, maintain and repair roofing for commercial and industrial businesses and to do all things necessary therewith to perform this business purpose.
- (b) To acquire the good will, rights, assets and properties, and to undertake the whole or any part of the liabilities of any person, firm, association or corporation; to pay for the same in cash, the stock or other securities of the corporation or otherwise; to hold, or in any manner dispose of the whole or any part of the business so acquired, and to exercise all the powers necessary or convenient in and about the conduct and management of any such business.
- (c) To enter into, make and perform contracts of every kind for any lawful purpose without limit as to amount, with any person, firm, association, or corporation, town, city, county, state, territory, government or governmental subdivision.
- (d) To enter into any plan or project, including any legal arrangement for sharing of profits, for the assistance and welfare of its employees.
- (e) To have one or more offices to carry on all its operations and businesses without restruction or limit as to amount, both within and

without the State of Alabama, other states, districts, territories, possessions or colonies of the United States, and in any and all foreign countries, in any lawful manner.

(f) To carry on any other lawful business in connection with the foregoing.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is Five Thousand (5,000) shares of common stock, with the par value of One Dollars (\$1.00) per share.

FIFTH: The number of directors constituting the initial Board of Directors of the corporation is one (1), and the name and address of the person to serve as director until the first annual meeting of the shareholders or until their successors are elected and shall qualify are:


