CORPORATE FORM WARRANTY DEED, JOINTLY FOR LIFE WITH REMAINDER TO SURVIVOR

That in consideration of Fifteen Thousand and 00/100'S *** (\$15,000.00) Dollars to the undersigned grantor, Reynolds & Rawson, Inc., (herein referred to as grantor) in hand paid by the grantee herein, the receipt whereof is acknowledged, the undersigned said grantor does by these presents grant, bargain, sell and convey unto Michael L. Robertson, an unmarried man, and Cindy Brasfield, an unmarried woman (herein referred to as grantee), for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate, situated in Shelby, County, Alabama, to-wit:

Lot A, according to the survey of the Amended Map of Russet Bend, Second Sector, as recorded in Map Book 13 page 47 in the Probate Office of Shelby County, Alabama; being situated in Shelby County, Alabama.
