AFFIDAVIT

Before me, the undersigned authority, a Notary Public, in and for said County, in said State, personally appeared Alice Hobson, who after being by me first duly sworn, deposes and says on oath as follows:

My name is Alice Hobson, and I am 80 years old and am familiar with the following facts, to-wit:

I am the present owner of the following described property:

Commence at the NW corner of the NE 1/4 of the SE 1/4 of Section 23, Township 21 South, Range 1 West; thence run South along the Quarter line 680 feet, more or less, to the South right of way line of an undefined and unnamed County Road and point of beginning; thence continue along same course 114 feet, more or less, to a found iron pin; thence 43 degrees 07 minutes 41 seconds left 213.30 feet to a found iron pin on the Northwestern right of way of a Southern Railroad Company rail line; thence 94 degrees 59 minutes 22 seconds left 140.0 feet along said right of way; thence 87 degrees 00 minutes left 264 feet, more or less, leaving said right of way to the Southeastern right of way of the previously mentioned unnamed County Road; thence run Southwesterly along said road right of way 53 feet, more or less, to the point of beginning. According to survey of Bart Carr, RLS #16685, dated January 23, 1990.

My grandfather, Hillard Gibb, had a deed to the above described property, prior to 1900. That deed has been lost without being recorded, but I have seen the deed myself. Hillard Gibb died intestate leaving my mother, Maggie Gibbs Bowden, as his sole surviving heir. She took possession of the property and maintained said property and paid taxes on the same until her death on June 22, 1956. She died intestate, leaving four children, namely: Naomi, Lucille, Andrew, and myself, Alice Hobson. My sisters and brother are all dead now and left no children. Upon my mother's death in 1956, I went into possession of the above described property, and have been in open, notorious, exclusive, adverse possession of same, paying taxes and using the same, since June 22, 1956. I have not heard of any other party or parties making any claim to said land.
