ARTICLES OF AMENDMENT
TO

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, as President and Secretary of Alabama Flying Service, Inc., a corporation organized and existing under the laws of the State of Alabama, hereby certify that, in accordance with Code of Alabama 1975, Sections 10-2A-110 and 10-2A-113, the Articles of Incorporation were amended by a unanimous vote of the Directors and the sole Shareholder, on the 12th day of March, 1990, on which date there were 1,000 shares outstanding and entitled to vote thereon, as follows:

ARTICLE IV of the Articles of Incorporation is hereby deleted in its entirety, and there is substituted in lieu thereof the following:

"ARTICLE IV

AUTHORIZED CAPITAL SHARES

The total number of shares which the Corporation shall have authority to issue is 2,000 shares of Common of the par value of \$1.00 per share, constituting a total authorized capital of \$2,000 and consisting of such one class only."

We further certify that the within Articles of Amendment are being filed in the Office of the Judge of Probate of Shelby County, Alabama, for the purpose of

effecting such amendment in accordance with the requirements of Code of Alabama 1975, Section 10-2A-114.
