- 2. The Chairman of the Board of Directors of said Authority and the Secretary of said Authority, do now, pursuant to 1975 Code of Alabama, 11-88-5, sign this document and certificate, to be filed for record in the office of the Judge of Probate of Shelby County, Alabama, in the name of and in behalf of said Authority, under its seal, reciting the adoption of said respective resolutions by the Board and by each of the said governing bodies and setting forth the proposed amendment.

- 3. The undersigned William T. Page was duly elected by the Shelby County Commission to fill the unexpired term of the aforesaid Raymond E. Thornburg, said term to expire on March 1,1993.
- 4. When the Certificate of Incorporation of the Authority was permitted by the Shelby County Commission on February 13, 1989, increasing the number of directors from three to five, the undersigned Larry Guy was appointed as a director to fill one of the two newly created director positions, and the term of said Larry Guy as such director will expire on March 1, 1993.
- 5. When the Certificate of Incorporation of the Authority was permitted by the Shelby County Commission on February 13, 1989, increasing the number of directors from three to five, Reid White, Sr. was appointed as a director to fill one of the two newly created director positions, and the term of said Reid White, Sr. as such director will expire on March 1, 1991. Said Reid White, Sr., resigned as such director on September 5, 1989, and has not served as a director of the Authority since September 5, 1989, although his resignation has not yet been accepted by the Shelby County Commission.
- 6. Consequently, the undersigned Thomas F. Snow and William T. Page occupy as directors of the Authority two of the three original Board of Directors positions and the undersigned
