**SUBSCRIPTION AGREEMENT**

I, the undersigned, do hereby severally subscribe for and agree to take and pay for the amount of stock set opposite my respective name, said stock to be issued by ARP, INC., an Alabama Corporation (the "Corporation"). I understand and agree that the capital stock subscribed for is to be paid for in full at such time as shall be directed by the Board of Directors, and that upon payment a Certificate will be issued for the number of shares I have severally subscribed. Any call made by the Board of Directors for payment on subscriptions shall be uniform as to all shares of the same class. In the case of default in the payment of any installment or call when due, the Corporation may proceed to collect the amount due in the same manner as any debt due the Corporation.

I further understand and agree that the By-Laws of the Corporation may subscribe other penalties for failure to pay installments of calls that may become due, but no penalty working a forfeiture of a subscription or of the amounts paid thereon, shall be declared against any subscriber, unless the amount due thereon remains unpaid for a period of twenty (20) days after written demand has been made therefor. 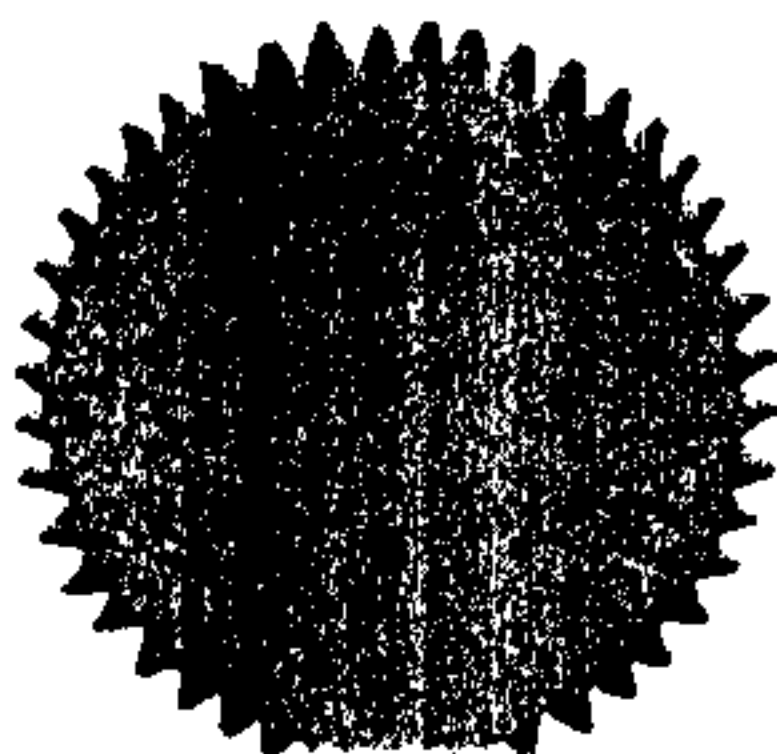
