The pointment is made under and by authority of the following provisions of the By Laws of the company, which are now in full force and effect.

Article 5, Section A.

The Board of Directors shall have the management of the business of the company, and in addition to the powers and authorities by these By-Laws expressly conferred upon them, may exercise all such powers and do all such acts and things, as may be exercised or done by the corporation.

Article 5, Section 6.

The Board of Directors may appoint additional officers and agents to perform such duties. This Power of Attorney is signed and scaled by facsimile under and by the authority of the following resolutions adopted by the Board of Directors of LAWYERS SURETY CORPORATION at a meeting duty held on January 29, 1972.

RESOLVED FURTHER that the signature of any authorized officers and the seal of the company may be affixed by facsimile to any power of atterney or certification thereof authorizing the execution and delivery of any bond, undertaking, recognizance, or other suretyship obligations of the company; and such signature and scal when so used shall have the same force and effect as though manually affixed.
