**ARTICLES OF INCORPORATION  
OF

**FIRST:** The name of the Corporation is All-Grade Paper Converting, Inc.

**SECOND:** The Corporation shall have perpetual duration.

**FOURTH:** The nature of the business or purposes to be conducted or promoted are:

(a) To engage in the business of converting paper rolls from one form to another and sale and distribution of such rolls as converted.

(b) To engage in any lawful act or activity for which corporations may be organized under the Alabama Business Corporation Act.

**FIFTH:** The total number of shares of stock which the Corporation shall have authority to issue is 20,000 shares, consisting of 20,000 shares of Common Stock, par value \$.01 per share.
