Subject to the rights, if any, of the holder of any prior mortgage set forth above, the Mortgagor hereby assigns and pledges to the Mortgagee as further security for the payment of the Debt each and every policy of hazard Insurance now on hereaften in effect which insures said improvements, or any part thereof, together with all the right, title and interest of the Mortgagor in and to each and every such policy, including but not limited to all of the Montgagor's night, title and interest in and to any premiums paid on such hazard insurance, including all rights to return premiums. power to lease and control the Real Estate, and with such other powers as may be deemed necessary.
