UNIFORM COVENANTS. Borrower and Lender covenant and agree as follows:

1. Payment of Principal and Interest; Prepayment and Late Charges. Borrower shall promptly pay when due the principal of and interest on the debt evidenced by the Note and any prepayment and late charges due under the Note.

2. Funds for Taxes and Insurance. Subject to applicable law or to a written waiver by Lender, Borrower shall pay to Lender on the day monthly payments are due under the Note, until the Note is paid in full, a sum ("Funds") equal to one-twelfth of: (a) yearly taxes and assessments which may attain priority over this Security Instrument; (b) yearly leasehold payments or ground rents on the Property, if any; (c) yearly hazard insurance premiums; and (d) yearly mortgage insurance premiums, if any. These items are called "escrow items." Lender may estimate the Funds due on the

basis of current data and reasonable estimates of future escrow items.

The Funds shall be held in an institution the deposits or accounts of which are insured or guaranteed by a federal or state agency (including Lender if Lender is such an institution). Lender shall apply the Funds to pay the escrow items. Lender may not charge for holding and applying the Funds, analyzing the account or verifying the escrow items, unless Lender pays Borrower interest on the Funds and applicable law permits Lender to make such a charge. A charge assessed by Lender in connection with Borrower's entering into this Security Instrument to pay the cost of an independent tax reporting service shall not be a charge for the purposes of the preceding sentence. Borrower and Lender may agree in writing that interest shall be paid on the Funds. Unless an agreement is made or applicable law requires interest to be paid. Lender shall give to Borrower, without charge, an annual accounting of the Funds showing credits and debits to the Funds and the purpose for which each debit to the Funds was made. The Funds are pledged as additional security for the sums secured by this Security Instrument.

If the amount of the Funds held by Lender, together with the future monthly payments of Funds payable prior to the due dates of the escrow items, shall exceed the amount required to pay the escrow items when due, the excess shall be, at Borrower's option, either promptly repaid to Borrower or credited to Borrower on monthly payments of Funds. If the *amount of the Funds held by Lender is not sufficient to pay the escrow items when due, Borrower shall pay to Lender any

Upon payment in full of all sums secured by this Security Instrument, Lender shall promptly refund to Borrower any Funds held by Lender. 3. Application of Payments. Unless applicable law provides otherwise, all payments received by Lender under paragraphs 1 and 2 shall be applied: first, to late charges due under the Note; second, to prepayment charges due under the

Note; third, to amounts payable under paragraph 2; fourth, to interest due; and last, to principal due.

4. Charges; Liens. Borrower shall pay all taxes, assessments, charges, fines and impositions attributable to the Property which may attain priority over this Security Instrument, and leasehold payments or ground rents, if any.

Borrower shall pay these obligations in the manner provided in paragraph 2, or if not paid in that manner, Borrower shall Borrower shall pay these obligations in the manner provided in paragraph 2, or if not paid in that manner, Borrower shall. pay them on time directly to the person owed payment. Borrower shall promptly furnish to Lender all notices of amounts to be paid under this paragraph. This insurance shall be maintained in the amounts and for the periods that Lender requires. The insurance carrier providing the insurance shall be chosen by Borrower subject to Lender's approval which shall not be

unreasonably withheld.

All insurance policies and renewals shall be acceptable to Lender and shall include a standard mortgage clause. Lender shall have the right to hold the policies and renewals. If Lender requires, Borrower shall promptly give to Lender. all receipts of paid premiums and renewal notices. In the event of loss, Borrower shall give prompt notice to the insurance

carrier and Lender. Lender may make proof of loss if not made promptly by Borrower.

Unless Lender and Borrower otherwise agree in writing, insurance proceeds shall be applied to restoration or repair of the Property damaged, if the restoration or repair is economically feasible and Lender's security is not lessened. If the restoration or repair is not economically feasible or Lender's security would be lessened, the insurance proceeds shall be applied to the sums secured by this Security Instrument, whether or not then due, with any excess paid to Borrower. If Borrower abandons the Property, or does not answer within 30 days a notice from Lender that the insurance carrier has offered to settle a claim, then Lender may collect the insurance proceeds. Lender may use the proceeds to repair or restore the Property or to pay sums secured by this Security Instrument, whether or not then due. The 30-day period will begin when the notice is given.

Unless Lender and Borrower otherwise agree in writing, any application of proceeds to principal shall not extend or postpone the due date of the monthly payments referred to in paragraphs 1 and 2 or change the amount of the payments. If under paragraph 19 the Property is acquired by Lender, Borrower's right to any insurance policies and proceeds resulting from damage to the Property prior to the acquisition shall pass to Lender to the extent of the sums secured by this Security

Instrument immediately prior to the acquisition.

6. Preservation and Maintenance of Property; Leaseholds. Borrower shall not destroy, damage or substantially change the Property, allow the Property to deteriorate or commit waste. If this Security Instrument is on a leasehold, Borrower shall comply with the provisions of the lease, and if Borrower acquires fee title to the Property, the leasehold and

fee title shall not merge unless Lender agrees to the merger in writing.

If Borrower fails to perform the 7. If Lender required mortgage insurance as a condition of making the loan secured by this Security Instrument, Borrower shall pay the premiums required to maintain the insurance in effect until such time as the requirement for the insurance terminates in accordance with Borrower's and Lender's written agreement or applicable law.

8. Inspection. Lender or its agent may make reasonable entries upon and inspections of the Property. Lender

that Borrower's consent.

12. Loan Charges. If the loan secured by this Security Instrument is subject to a law which sets maximum loan charges, and that law is finally interpreted so that the interest or other loan charges collected or to be collected in connection with the loan exceed the permitted limits, then: (a) any such loan charge shall be reduced by the amount necessary to reduce the charge to the permitted limit; and (b) any sums already collected from Borrower which exceeded permitted limits will be refunded to Borrower. Lender may choose to make this refund by reducing the principal owed under the Note or by making a direct payment to Borrower. The Note Holder will then determine the amount of the monthly payment that would be sufficient to repay the unpaid principal that I am expected to owe at the Change Date in full on the maturity date at my new interest rate in substantially equal payments. The result of this calculation will be the new amount of my monthly payment.

(D) Limits on Interest Rate Changes

ADDENDUM TO ADJUSTABLE RATE RIDER (Fixed Rate Conversion Option)

NOTICE: THE SECURITY INSTRUMENT SECURES A NOTE WHICH CONTAINS A PROVISION ALLOWING FOR CHANGES IN THE INTEREST RATE. INCREASES IN THE INTEREST RATE MAY RESULT IN HIGHER PAYMENTS, DECREASES IN THE INTEREST RATE MAY RESULT IN LOWER PAYMENTS.

This Addendum to Adjustable Rate Rider is made this 20th __day of ___April_____, 19___90____, and is incorporated into and shall be deemed to amend and supplement the Mortgage/Deed of Trust/Trust Indenture and Adjustable Rate Rider (the "Security Instrument") of the same date given by the undersigned (the "Borrower") to secure Borrower's Note to BancBoston Mortgage Corporation (the "Lender") of the same date (the "Note") and covering the property described in the Security Instrument and located at __5147 Stonehaven Drive, Birmingham, Alabama 35244

MODIFICATIONS: In addition to the covenants and agreements made in the Security Instrument, Borrower and Lender further covenant and agree as follows:

A. FIXED INTEREST RATE CONVERSION OPTION

1. Option to Convert to Fixed Rate

I have a Conversion Option that I can exercise unless I am in default or this Section A.1. will not permit me to do so. The "Conversion Option" is my option to convert the interest rate I am required to pay by the note from an adjustable rate with interest rate limits to the fixed rate calculated under Section A.2. below.

The conversion can take place only on a date(s) specified by the Note Holder during the period beginning on the first Change Date and ending on the sixtieth payment due date. Each date on which my interest rate can convert from an adjustable rate to a fixed rate is called a "Conversion Date". I can convert my interest

rate only on a Conversion Date. If I want to exercise the Conversion Option, I must first meet certain con-Editions. Those conditions are that: (i) I must give the Note Holder notice that I want to do so; (ii) on the Conversion Date, I must be current with respect to all payments in the twelve months prior to the Conversion Date and I must not have had any paycoments 30 days or more delinquent, nor more than one payment 15 days delinquent during the preceding 12 months; (iii) by a date specified by the Note Holder, I must pay the Note Holder a non-refundable conversion fee equal to U.S. \$250.00 if allowed Sunder applicable state law; (iv) on the Conversion Date, the property value must be at Reast equal to its value at the time of the origination of the loan, and I will pay to the Note Holder an amount sufficient to cover the cost of a new appraisal to determine the current value of the property, and verify that the new loan-to-value ratio has not increased; (v) upon the notification date, I must qualify under the then current Note Holder's underwriting guidelines and submit an updated application and credit report, at my own expense; (vi) I must intend to occupy the property as my primary residence; (vii) I must sign and give the Note Holder any documents the Note Holder requires to effect the conversion (including, without limitations, any document changing the terms __of the Note to effect the conversion).

2. Calculation of Fixed Rate

If my loan has an original balance of \$ 187,450 or less, my new, fixed interest rate will be equal to the FNMA required net yield of a date and time of day specified by the Note Holder for 30-year fixed rate mortgages covered by applicable 60-day mandatory delivery commitments under the scheduled/actual reporting system, plus five-eighths of one percentage point (0.625%) rounded up to the nearest one-eighth of one percentage point (0.125%). If my loan had an original balance in excess of \$ 187,450 my new fixed interest rate will be equal to the FNMA required net yield as of a date and time of day specified by the Note Holder for 30-year fixed rate mortgages covered by the applicable 90-day mandatory delivery commitments under the scheduled/actual reporting system, plus seven-eighths of one percent (0.875%) rounded up to the nearest one-eighth of one percentage point (0.125%). My new fixed interest rate will never be higher than the highest rate disclosed in the Note.

If this required new yield cannot be determined because the applicable commitments are not available or for any other reason, the Note Holder may deter-

mine my interest rate by using comparable information.

If I choose to exercise the Conversion Option, The Note holder will determine the amount of the monthly payment that would be sufficient to repay the unpaid principal I am expected to owe on the Conversion Date in full on the maturity date at my new fixed interest rate in substantially equal payments. The result of this calculation will be the new amount of my monthly payment. Beginning with my first monthly payment after the Conversion Date, I will pay the new amount as my monthly payment until the maturity date.

TRANSFER OF THE PROPERTY OR A BENEFICIAL INTEREST IN B. BORROWER

If my interest rate is converted to a fixed rate, some of the conditions under which I may be required to make immediate payment in full of all amounts I owe under the Note, which are described in the section of the Note captioned "Uniform Secured Note" shall cease to be in effect. Instead, some of these conditions will be described as follows:

Transfer of the Property or a Beneficial Interest in Borrower. If all or any part of the Property or any interest in it is sold or transferred (or if a beneficial interest in Borrower is sold or transferred and Borrower is not a natural person) without Lender's prior written consent, Lender may, at its option, require immediate payment in full of all sums secured by this Security Instrument.
