Commence at the Northeast corner of the Northeast $\frac{1}{4}$ of the Southeast $\frac{1}{4}$ of Section 31, Township 18 South, Range 1 West and run in a Westerly direction along the $\frac{1}{4}$ - $\frac{1}{4}$ line a distance of 271.21 feet to a Point of Beginning; thence deflect 90 degrees 28' 40" to the left and leaving said $\frac{1}{4}$ - $\frac{1}{4}$ line run in a Southerly direction a distance of 1178.07 feet to a point on the North right of way line of U. S.
