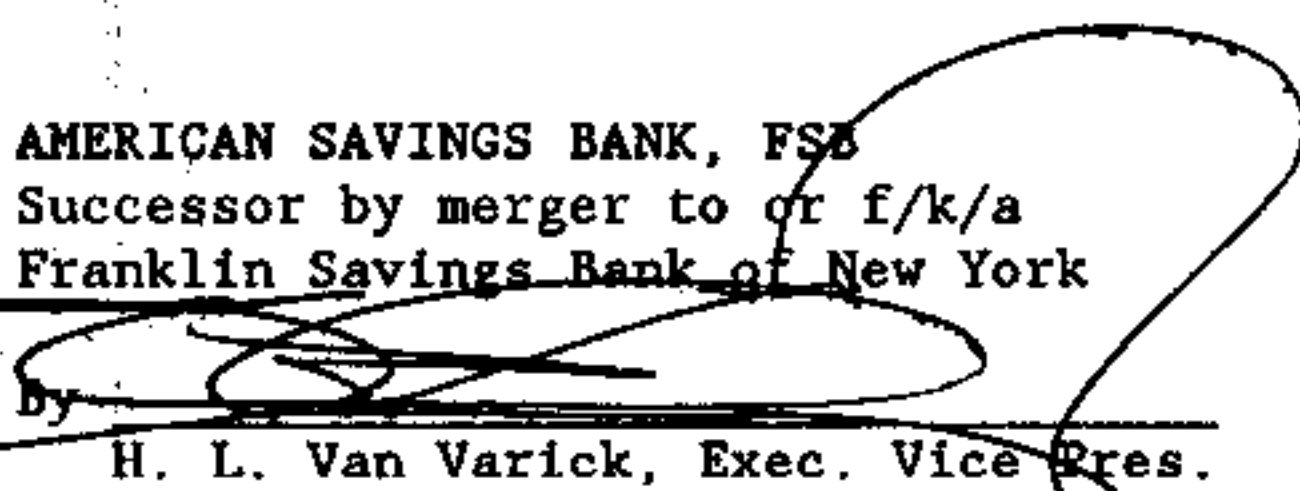
ASSIGNMENT OF MORTGAGE

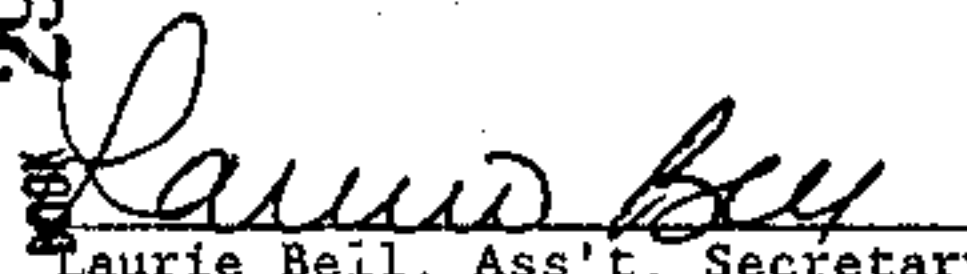

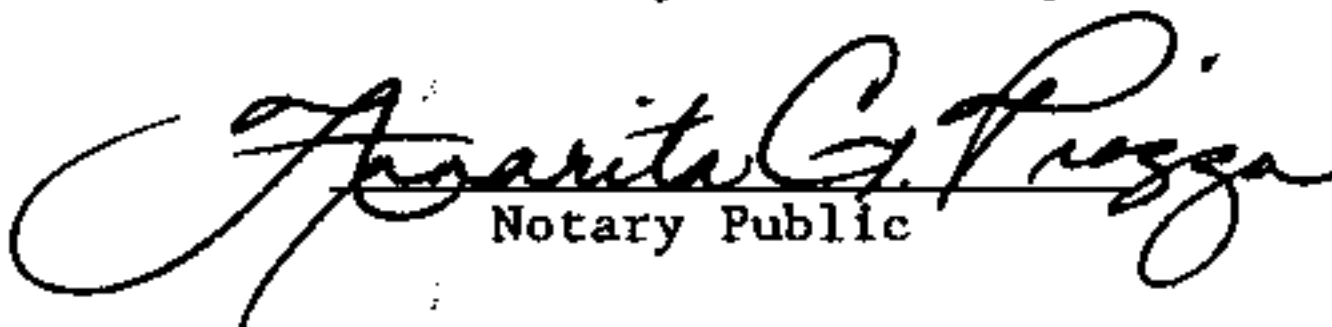

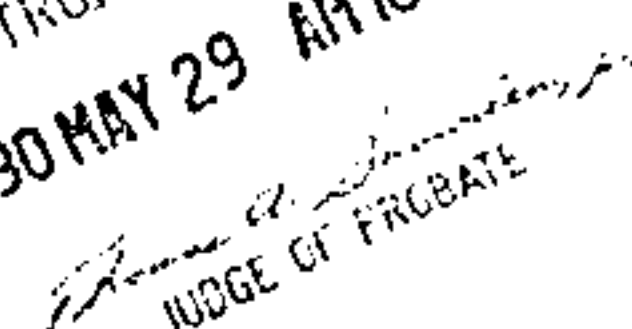
