THIS AGREEMENT, made and entered into this the 26 day of May 1990, by and between J. E. Cain (hereinafter called the "Seller") and International Paper Co. (hereinafter called the "Buyer").

1. Timber being conveyed from sale areas as shown on attached map and hereby made a part of this contract are as follows:

Sale Area "A": All Pine Species and Hardwood Species marked with a yellow "X"

Sale Area "B": All merchantable Fine and Hardwood trees except those marked with a blue band.

Sale Area "C": All merchantable Pine Species and Hardwood Species except those marked with a blue band.

Lake "Out" Area: Only Pine Species marked with a yellow "X"

2. The above described timber and/or trees conveyed hereby is located on the following described real estate in Shelby County, Alabama, to-wit:

150 acres more or less in Sections 33 and 34, Township 20 South, Range 1 East, Shelby County, Alabama, as shown on attached map.

3. The Buyer agrees to pay to the Seller for the timber and/or trees conveyed as follows:

30,649.00 on execution of this agreement.

#50,000.00 plus accrued interest at seven (7%)
percent to be paid on before January 15,1991.

4. The Seller expressly covenants and agrees to and with the Buyer that Seller is lawfully seized in fee simple of the timber and/or trees hereinabove described and conveyed; that the same is free from any and all liens, mortages and encumbrances; that Seller has a good and perfect right to sell and convey the same as aforesaid; and that Seller does and will, and his executors and admini-

strators shall, forever warrant and defend the title to said timber and/or trees, and the possession thereof, unto Buyer, its succes sors and assigns, against the lawful claim or claims of and and * all persons whomsoever.

- The Seller hereby gives and grants unto the Euyer the right to enter said above described lands and to cut and remove therefrom the timber and/or trees hereby conveyed, it being expressly understood, however, that in cutting and removing said timber and/or trees the Buyer shall not cut from or off of said lands any timber and/or trees other than those hereby conveyed, except such small timber or trees as may be necessary to cut and remove in felling, cutting and removing said timber and/or trees hereby conveyed, or in order to open up necessary roadways to enable the Buyer to haul from said land the timber and/or trees hereby conveyed. Seller reserves the right to designate or approve any new roads across said land.
- 6. All public utility lines, creek, ditches and pastures located on the above described land shall be protected by the Buyer in the logging operation. No tops or other logging debris oo shall be left in the power line, creek or pastures. Roads or fences if damaged, shall immediately be restored to original or better condition. Seller shall not be liable for any claims or damages which may arise from the exercise by the Buyer, his contractors, assigns, or agents, of the rights herein granted.
 - 7. The Buyer agrees to use reasonable precaution against fire starting on said land, and in the event fires occur on said land or on any other land of Seller in the vicinity thereof, the Buyer shall immediately notify the Seller and the State Division of Forestry of the location of the fire; and shall use reasonable means to extinguish said fire and to prevent damage to the timber, trees and timber growth on said land.
 - 8. The Buyer shall report and pay to the State of Alabama the Forest Products Severance Tax for timber and pulpwood cut under this agreement.
 - 9. The Buyer in the exercise of the rights herein granted shall not in any way interfere with the reasonable use by the Seller of said lands or with the reasonable use by grantees, contractors, or agents of the Seller or any portion of said land under rights heretofore or hereafter granted by the Seller. It is also agreed that as to timber and pulpwood herein reserved by the Seller, that the Seller reserves and has the right to sell and convey said timber and pulpwood to other parties, together with the privilege of cutting and removing the same on any or all parts of the above described lands.
 - 10. It is distinctly understood and agreed that the Seller has no right and retains no right with regard to the details of the

work, personnel of the workers, or the hours of work, or other conditions of the employment of those employed or used by the Buyer, or any contractor of the Buyer, in the performance of this work.

- of 1990, and shall terminate and end as soon as all of the timber and/or trees hereby conveyed are cut and removed from said lands, or the 200 day of November, 1991, whichever is the earlier and on such date all of the rights and interest of the Buyer hereunder shall cease and terminate and the title to all timber and/or pulpwood then standing, lying or growing on said lands shall revert to the Seller. The Seller reserves the right to temporarily halt harvesting operations should harvesting operations during wet weather cause excessive damage. If Seller should exercise rights as stated above, then an extension equal to length of time harvesting was halted shall be granted by Seller at no change to Buyer.
- 12. Buyer shall use reasonable care in harvesting to preyent damage to residual stand. Buyer shall not cut or excessively
 damage undesignated trees. If Buyer or Buyer's agents or contractors
 cuts or excessively damages undesignated trees, then Buyer hereby
 agrees to pay Seller a penalty for each undesignated tree as
 follows:
 - For undesignated trees with stumps 10" and under in diameter."
 \$20.00; 11" through 17", \$50.00; 18" and up, \$75.00 provided that
 any such penalty may be waived by Seller in Seller's sole discretion
 if Seller shall deem that such cutting was necessary to the operation
 hereunder.


