

ARTICLES OF INCORPORATION

OF

ADEPT PUBLISHING, INC.

The undersigned, acting as incorporators of a corporation under the Code of Alabama, adopt the following Articles of Incorporation for such incorporation:

(1) The name of the corporation shall be ADEPT Publishing, Inc., and the period of its duration shall be perpetual.

(2) The objects for which the corporation is formed are:

(a) To create copy for and to publish the same for the general public.

(b) The transaction of any and every lawful business for which a corporation may incorporate under the laws of the State of Alabama and generally to carry on any and every lawful business and to do anything in furtherance of the carrying on of any lawful business.

(3) The amount of the total authorized capital stock of this corporation is fixed at \$1,000.00 divided into 1,000 shares of common stock of the par value of \$1.00 per share. The amount of capital stock with which the corporation shall begin business is \$1,000.00 being 1,000 shares of common stock of the par value of \$1.00 per share.
