**CORPORATE FORM WARRANTY DEED, JOINTLY FOR LIFE WITH REMAINDER TO SURVIVOR**

KNOW ALL MEN BY THESE PRESENTS,

SHELBY COUNTY )

That in consideration of One Hundred Eighteen Thousand Nine Hundred and 00/100'S \*\*\* (\$118,900.00) Dollars to the undersigned grantor, J. Elliott Corp., a corporation, (herein referred to as grantor) in hand paid by the grantee herein, the receipt whereof is acknowledged, the undersigned said grantor does by these presents grant, bargain, sell and convey unto David G. Traynor, husband, and Lisa G. Traynor, his wife (herein referred to as grantee), for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate, situated in Shelby County, Alabama, to-wit:
