LEGAL DESCRIPTION:

PARCEL I:

Commencing at the NE corner of the NE 1/4 of NW 1/4 of Section 2, Township 20 South, Range 1 West, run South along the East line of said 1/4-1/4 Section to a Shelby County gravel road; thence in a Northwesterly direction along the center line of said gravel road 175 feet, more or less, to an intersection with an old logging road, being the point of beginning; thence begin at the center line of said old logging road, run thence in a Southerly direction along said center line as it meanders for a distance of 263 feet to a metal stake; thence Westerly and parallel with the North line of said 1/4-1/4 Section a distance of 310 feet to a metal stake marking the Southwest corner; thence turn an angle to the right of 91 degrees 26 minutes and run in a Northerly direction a distance of 415 feet to a metal stake; thence continue Northerly to the center line of the aforementioned Shelby County gravel road; thence in an Easterly direction along the center line of said gravel road as it meanders for a distance of 500 feet, more or less, to the point of beginning. Situated in Shelby County, Alabama.

PARCEL II:

Commencing at the NE corner of the NE 1/4 of NW 1/4 of Section 2, Township 20 South, Range 1 West, run South along the East line of said 1/4-1/4 Section to a Shelby County gravel road; thence in a Northwesterly direction along the center line of said gravel road a distance of 175 feet, more or less, to an intersection with an old logging road; thence run in a Southerly direction along the center line of said old logging road as it meanders for a distance of 263 feet, more or less, to the point of beginning; thence begin at the center line of said old logging road run thence in a Southerly direction along said center line as it meanders for a distance of 475 feet, more or less, to a point in the center line of said old road being at the South edge of a cleared field; thence West and parallel with the North line of said 1/4-1/4 Section to a point in the middle of the Yellow Leaf Creek; thence in a Northwesterly direction along the center of said creek a distance of 300 feet, more or less; thence in a Northerly direction a distance of 200 feet to a metal stake, marking the Northwest corner; thence at an angle of 91 degrees 26 minutes in an Easterly direction a distance of 310 feet, more or less, to the point of beginning.
