ADDENDUM NO. 1 TO MORTGAGE DEED

ADDENDUM NO. 1 TO MORTGAGE DEED attached to and made a part of that certain Mortgage Deed (the "Mortgage") dated June 22, 1990, between CLAYTON-BAILEY PROPERTIES, an Alabama general partnership ("Mortgagor") and FIRST ALABAMA BANK/SHELBY COUNTY ("Mortgagee").

The following additional terms and provisions are made a part of the Mortgage. In the event of any conflict between the terms and provisions of the Mortgage and those of this Addendum, the terms and provisions of this Addendum shall prevail and control.

- 1. PARTIAL RELEASES. Provided Mortgagor is not then in default of the Mortgage, the Note or any other instrument relating to the indebtedness owed by Mortgagor to Mortgagee, immediately upon receipt by Mortgagor of the Net Proceeds (as defined below) with respect to a particular real estate parcel, Mortgagor shall deliver to Mortgagee a partial release thereof from the lien of the Mortgage. All costs and expenses with respect to such partial release shall be borne by Mortgagor. For purposes of this Paragraph, the term "Net Sales Proceeds" shall mean the product of:
 - (i) the difference between (a) the number 1 and (b) the highest combined marginal federal and state income tax rate applicable to individuals for the year in which such sale occurs; and
 - (ii) the gross sales proceeds with respect to a particular real estate parcel reduced by all costs and expenses incurred by Mortgagor with respect to such sale.
- 2. <u>DEFAULT</u>. The following shall be an event of default under the Mortgage or Note:
- (a) Nonpayment of principal or interest when due and payable and the same shall remain unpaid for more than ten (10) banking days after written notice from Mortgagee to Mortgagor;
- (b) Default in the performance or observance of any other covenant or provision of the Note or Mortgage and such default shall have continued for more than twenty (20) banking days after written notice thereof has been given to Mortgagor from Mortgagee.
