I, PHILIP J. KYSER, a resident of Demopolis, Marengo County, Alabama, and being over the age of nineteen (19) years, being of sound mind and disposing memory, do make, publish and declare this instrument as and for my Last Will and Testament, hereby revoking all other Wills and testamentary dispositions heretofore made by me.

ITEM ONE: I direct that all of my just debts, including the expenses of my last illness and funeral, shall be paid out of my estate, by the Co-Executrix hereinafter named, as soon after my death as practicable.

ITEM TWO: I do hereby give, devise and bequeath the sum of Fifteen Thousand and No/100's (\$15,000.00) Dollars to the First Baptist Church of Demopolis, Alabama.

ITEM THREE: I have given to my daughters, Betty K. Mayton, Marilyn K. Braswell and Carolyn K. Dunlavy, as joint tenants with right of survivorship, a \$25,000.00 life insurance policy upon my life. Only in the event it is necessary to ratify and confirm said gift, then I hereby ratify and confirm the same to the extent necessary to vest the ownership interest in said life insurance policy in their names. I have requested and I do further request by this provision in my Will, but I do not direct or order that they do so, merely request, that they use the proceeds therefrom

to care for my daughter, Phyllis K. Kratochvill, Woodley Manor, 3312 Woodley Road, Montgomery, Alabama 36111. Said care, protection and provisions for my said daughter to be to the extent that my three (3) daughters deem such care to be needed, necessary and proper. If, upon the death of my daughter, Phyllis K. Kratochvill, there are funds still remaining from said insurance policy which have not been expended upon her during her lifetime, the balance remaining shall be equally divided among my three (3) daughters, Betty K. Mayton, Marilyn K. Braswell and Carolyn K. Dunlavy, share and share alike, in equal parts and should any of my said three (3) daughters be deceased, the child or children of said deceased daughter will take the part to which their parent would have been otherwise entitled, to be theirs absolutely and forever.

ITEM FOUR: I do hereby give, devise and bequeath unto my wife, Helen T. Kyser, the following bequests forever and absolutely:

- (a) My personal automobile which I am driving at the time of my death.
- (b) A life estate in my personal home so long as she lives or until she remarries, if she does, whichever may first occur, and at the first occurrence of either remarriage or death, the title to my said home shall revert to fee simple ownership in my seven (7) children equally, or if any of my children should predecease me, my child's share shall go to their child or children equally.

It is further my desire and my instruction that should a roof be needed on my personal home at any time during the period of time my wife has her life estate in the home, the cost of said roof be paid from my estate and at no cost to my wife.

- (c) All furniture, appliances and all personal property located in my home for the use of my wife during her lifetime and until she dies or until she remarries, whichever may first occur, and at the first occurrence of either remarriage or death, all furniture, appliances and all personal property shall revert to ownership in my seven (7) children equally, or if any of my said children should predecease me, my child's share shall go to their child or children equally. There are certain items of personal property and furniture that I own which have sentimental value or special value to some of my children. I wish for my children to have the special items of personal property immediately upon my death and I am confident that my wife and my children can agree on these special items without any problem or confusion. These items of personal property will not be a portion of those items in which my wife shall have a life estate. All items of furniture brought to our marriage by my wife or purchased during our marriage shall be hers in fee simple, totally and absolute.
- (d) All money which is located in the Household Operating Account which is at Robertson Banking Company, Demopolis, Alabama.
- (e) In addition to all of the above bequests to my beloved wife, I leave to her the payment of a lump sum of \$75,000.00 in cash.

ITEM FIVE: I do hereby give, devise and bequeath all the rest, residue and remainder of my estate, subject to the requirements of all preceding paragraphs, unto my seven (7) children, Philip J. Kyser, Jr., Betty K. Mayton, Bobby L. Kyser, Phyllis K.

Kratochvill, Edmund C. Kyser, Marilyn K. Braswell and Carolyn K. Dunlavy, all property of whatsoever kind and nature, whether real, personal or mixed, wherever located, owned by me at the time of my death or to which I may be entitled, to be theirs in fee simple, equally, share and share alike, absolutely; the children (including adopted children) of any deceased child of mine, shall be entitled to such deceased child's share equally, per stirpes.

ITEM SIX: I hereby nominate, constitute and appoint Betty K. Mayton, Marilyn K. Braswell and Carolyn K. Dunlavy as Trustees for my daughter, Phyllis K. Kratochvill, to receive and administer all funds or assets which may be inherited by her under the terms of this Will, and I direct that they shall administer the trust and income therefrom as hereinafter set forth and upon the death of the said Phyllis K. Kratochvill, the assets remaining, if any, therein shall be distributed in equal parts, share and share alike, to the children of the said Phyllis K. Kratochvill and the descendants of any deceased children per stirpes. I further direct, in the event any of my said Trustees should die during the term of said trust or for any reason become unable or unwilling to serve, the survivor or survivors thereof shall continue to serve. I further exempt said Trustees from bond of any kind and they shall not be required to report to any Court in connection with their proceedings as said Trustees.

I authorize and direct my said Trustees to take charge of, manage and control said trust estate; and I do hereby authorize said Trustees to sell, exchange, transfer or convey all or any part of said trust estate upon such terms and conditions as they may see fit; to invest and reinvest said trust estate and the proceeds of sale or disposal of any portion thereof, in such loans, or other property, real or personal, whether so called "legal" investments of trust funds or not, as they may deem suitable, and

Kyser, and the descendants of any deceased children, per stirpes. I further direct, in the event any of my said Trustees should die during the term of said trust or for any reason become unable or unwilling to serve, the survivor thereof shall continue to serve as Trustee of this trust. I further exempt said Trustees or Trustee from bond of any kind and they shall not be required to report to any Court in connection with their proceedings as said Trustees.


I authorize and direct my said Trustees to take care of, manage and control said trust estate; and I do hereby authorize said Trustees to sell, exchange, transfer or convey all or any part of said trust estate upon such terms and conditions as they may see fit; to invest and reinvest said trust estate and the proceeds of sale or disposal of any portion thereof, in such loans, stocks, bonds or other securities, mortgages, common trust funds or other property, real or personal, whether so called "legal" investments of trust funds or not, as they may deem suitable, and to change investments and to make new investments from time to time as they may deem necessary or desirable. Kyser, and that as much of the income from the trust as is needed, in the full discretion of the Trustees, shall be so expended and at any time in the opinion of the Trustees it is necessary to go into the principal for the purpose of caring for and protecting my said son, Bobby L. Kyser, my Trustees are authorized to expend both income and principal in any amount they deem advisable and necessary.

I specifically request and direct that my Trustees of this trust make no loans or advances for my son, Bobby L. Kyser, or for any other person, including any children of Bobby L. Kyser, and that no expenditures be made that are not for the personal maintenance, well-being and protection of my son, Bobby L. Kyser, during his lifetime.

ITEM EIGHT: I hereby nominate, constitute and appoint as Co-Executrix of this, my Last Will and Testament, my wife, Helen T. Kyser, and my daughters, Betty K. Mayton and Carolyn K. Dunlavy,

and I direct that Letters Testamentary be issued to them without their being required to make, execute or deliver any bond for the performance of their duties as such Co-Executrix. I further direct that in the event any of my said appointed Co-Executrix should die prior to serving as Executrix or during the term of any of their duties herein provided, or for any reason should be unable or unwilling to serve, the survivor or survivors shall continue to serve with the same powers and rights as herein provided. I hereby vest in my said Co-Executrix full power to sell, convey, rent, mortgage, transfer and assign any and all of my said property upon such terms and conditions as they may deem best. I hereby exempt my Co-Executrix from filing any inventory of my estate, from making an accounting to any Court and from obtaining any order, decree or process from any Court whatsoever.




