ARTICLES OF DISSOLUTION PURSUANT TO

Pursuant to the provisions of Section 10-2A-190 of the Code of Alabama (1975) the undersigned Corporation adopts the following Articles of Dissolution for the purpose of dissolving the Corporation:

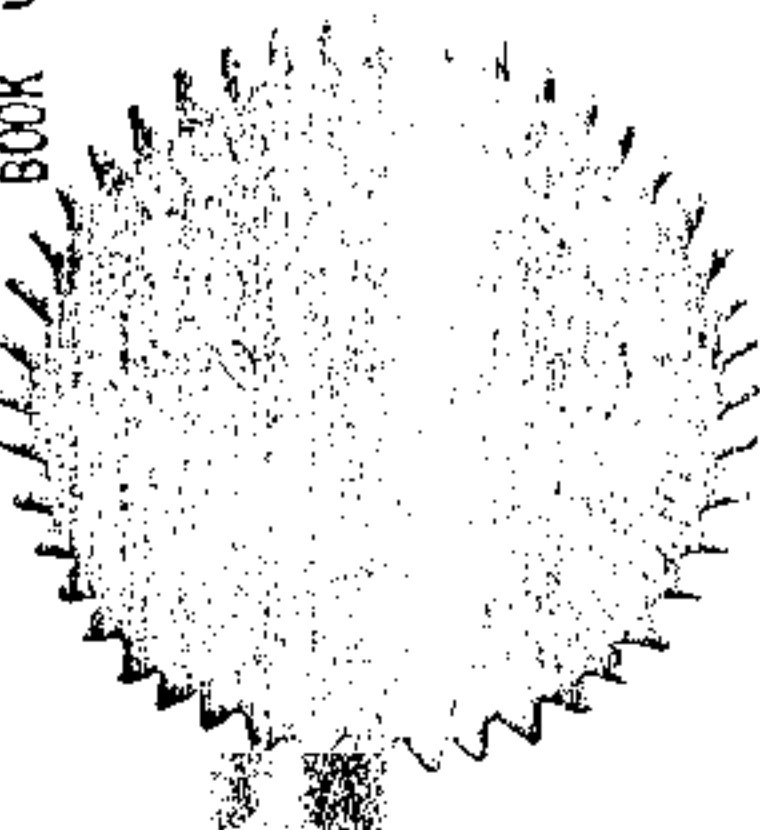
