ARTICLES OF INCORPORATION OF DAVID ENTERPRISES, INC.

The undersigned, acting as incorporators of the corporation under the Code of Alabama, pursuant to the provisions of the Alabama Business Corpoartion Act of 190, Act no. 80-633, adopts the following Articles of Incorporation.

FIRST

The name of the corporation is David Enterprises, Inc.

SECOND

The period of its during is perpetual.

THIRD.

The purpose or purposes for which the corporation is organized is to operate a "Sneaky Petes" franchise and other retail food outlets.

FOURTH

The aggregate number of shares which the corporation shall have authority to issue is One Thousand (1,000) shares and all of such shares shall be with a \$1.00 par value.

The corporation, being a "small business", as defined by Section 1244(c)(2) of the Internal Revenue Code of 1954, as amended, shall be authorized to issue its common stock pursuant to a plan adopted in accordance with said provisions of Section 1244 of the Internal Revenue Code of 1954, as amended.

<u>FIFTH</u>

Provisions for the regulation of the internal affairs of the corporation are:

- A. Subject to restrictions, if any, that are herein expressed and such restrictions, if any, as may be set forth in the By-Laws, the Board of Directors shall have the general management and control of the business and may exercise all of the corporation except such as may be by statute, or by the By-Laws as constituted and the time expressly conferred or reserved to the stockholders.
- No contract or other transaction between the corporation В. and any other firm, association or corporation shall be effected or invalidated by the fact that any one or more of the Board of Directors of the Corporation is interested in or is a member, director or officer of such firm or corporation and any director or directors, individually or jointly, may be a party or parties to or may be interested in any contract or transaction of the corporation in which the corporation is interested; no contract, act or transaction of the corporation with any person, firm, association or corporation shall be effected or invalidated by the fact that any member of the Board of Directors of the corporation was a party or parties to or interested in such contract, act or transaction or in any way connected with such person, persons, firm, association, or corporation and each and every person who may become a member of the Board of Directors of this corporation is hereby relieved from any liability that might otherwise exist from contracting with a corporation for the benefit of himelf or any firm, association or

or corporation in which he may be in any way interested.

- C. This corporation shall have the power in accordance with the By-Laws, to acquire any or all of the shares owned and held by such shareholder as should desire to sell, transfer, or otherwise dispose of his shares in accordance with the By-Laws adopted by the shareholders of this corporation, provided the capital of the corporation is not impaired.
- D. This corporation shall have the power to enter into, for the benefit of its employees, any one or more than one of the following:
 - 1. Pension Plan.
 - A Profit Sharing Plan.
 - 3. Deferred Compensation Plan.
 - 4. Health Care Plan.
 - 5. Any other requirement or incentive compensation plan.
