STATUTORY WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS, That for and in consideration of One Hundred Thirteen Thousand and NO/100 (\$113,000.00) Dollars to the undersigned GRANTOR in hand paid by the GRANTEES herein, the receipt whereof is acknowledged, SouthLake Construction and Development, Inc., an Alabama Corporation (GRANTOR) does grant, bargain, sell and convey unto Margaret Ellen Ream, Virgil Michael Ream and Sally Ream (GRANTEES) for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate situated in Shelby County, Alabama to-wit:

Lot 31-A, according to the Map of Southlake Townhomes, Second Addition, being a resurvey of a Lots 21 thru 43, pa part of 44, and acreage, Southlake Townhomes as recorded in Map Book 13, Page 66 in the Probate Office of Shelby County, Alabama; being situated in Shelby County, Alabama.

Mineral and mining rights excepted.
