VERIFIED CLAIM OF LIEN

✓ The E2 Group, a corporation qualified under the laws of the State of Alabama, by and through Leslie Keith Faciane who has personal knowledge of the facts herein set forth, files this statement in writing, verified by his oath. The E2 Group claims a lien upon certain real property situated in Shelby County, Alabama, more particularly described as follows, to-wit:

Lot 81, Block 4 Inverness Point, Phase II, as recorded in Map Volume 13, Page 19, in the office of the Judge of Probate, Shelby County, Alabama.

This lien is claimed, separately and severally, as to the land, buildings and improvements thereon to the extent of the entire lot or parcel which is contained within a city or town. If said land is not within a city or town, this lien is claimed, separately and severally, as to the buildings and improvements located on the above-described real property, plus one (1) acre of land surrounding and contiguous thereto.

This sum of money is due and owing for materials and labor




