FINAL JUDGMENT OF DIVORCE

THIS CAUSE coming on to be heard on the 18th day of May, 1990, was submitted for Final Judgment on Plaintiff's complaint, Defendant's answer thereto and Plaintiff's amendment to complaint. Upon consideration thereof, together with ore tenus testimony, the Court is of the opinion the following order should be entered.

Accordingly, it is ORDERED, ADJUDGED, and DECREED by the Court:

- I. That the bonds of matrimony heretofore existing between the parties are dissolved and the said Anna Mas Comeaux Gould and the said James Riley Gould are divorced each from the other.
 - 2. That neither party shall marry again except to each other until sixty (60) days after the date of this Judgment of Divorce, and if appeal is taken (which must be instituted within forty-two (42) days from the Judgment, or from the date that a post-trial motion is denied), then neither party shall again marry except to each other during the pendency of the appeal.
 - 3. That the costs of Court are hereby taxed against the Defendant.

 The land and mobile home of the parties located in Shelby County,

 Alabama is hereby awarded to the Defendant and the Plaintiff is divested of any

 right, title and interest therein. The Plaintiff is hereby ordered to execute

 and deliver to the Defendant a deed transferring all of her right, title and interest
 in and to said property to the Defendant within thirty (30) days of the date of this

 decree.
 - 5. That the Defendant is also awarded the travel trailer and the real estate located in Florida.

- 6. That the Defendant is awarded all the household appliances, furniture, and furnishings located in the mobile home of the parties with the exception of the following items which shall be that of the Plaintiff:
 - The double bed and two lamps located in the master bedroom

- Table and six chairs located in the dining room (d)
- (e) One Lazy Boy chair to be chosen by the Defendant
- 7. That the Defendant shall be awarded all the vehicles and the boats of the parties and shall pay any and all indebtedness thereon. The Plaintiff shall transfer any right and title that she has therein if necessary by appropriate instrument.
- 8. That the Defendant is hereby awarded any and all bank accounts and money in his possession and in which title thereto resides in him.
- 9. That the Plaintiff is hereby awarded any and all bank accounts and money in her possession and in which title thereto resides in her.
- 10. That the Defendant shall pay to the Plaintiff the sum of Five Thousand and no/100 Dollars (\$5,000.00) as alimony in gross, payable at the rate of One Hundred and no/100 Dollars (\$100.00) per month for fifty (50) consecutive months with the first payment being due and payable on the first day of July, 1990, and subsequent payments being due and payable on the first day of each month thereafter.
- 11. That the Defendant shall pay to the Plaintiff the sum of One Hundred Fifty and no/100 Dollars (\$150.00) per month as periodic alimony, the first payment to be due and payable on the first day of July, 1990 and subsequent payments due and payable the first day of each month thereafter until the said Plaintiff shall either die or remarry, or until Defendant shall die, whichever occurs first.
- 12. That the Defendant shall keep Plaintiff under his medical coverage for one year from the date hereof and furnish Plaintiff a medical card for same.
- 13. That the Defendant shall pay to the Plaintiff the sum of Two Thousand Two Hundred Eighty-two and 50/100 Dollars (\$2,282.50) with which to pay her attorney of record, the Honorable Margie Searcy, for professional services rendered in this 28 29 30 JONE and OPDERED +bis 2077 JONE and OPDERED +bis
