

ARTICLES OF INCORPORATION OF

ANN C. MITCHELL MEMORIAL FOUNDATION, INC.

The undersigned, acting as incorporator of a nonprofit corporation under the Alabama Nonprofit Corporation Act, adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is the ANN C. MITCHELL MEMORIAL FOUNDATION, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purposes for which the corporation is organized are: To provide scholarships for students pursuing degrees in education or related fields. To solicit, collect, receive, accumulate, administer and disburse funds and property in such a manner as will, in the sole discretion of the board of directors, most effectively operate to further religious, charitable, or educational purposes, either directly or by contributions to any organization described in Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future tax code, with the exception of organizations testing for public safety. To do any or all of the things hereinabove set forth, and all things usual, necessary or proper in furtherance of or incidental to said purposes. Said corporation is organized exclusively for charitable, religious, and educational purposes, including for such purposes, the making of distributions to organizations that qualify as

exempt organizations under Section 501(c)(3) of the Internal Revenue Code or corresponding section of any future federal tax code.

FOURTH: There shall be four (4) members of the initial board of directors of the corporation, and the names and addresses of the persons who are to serve as members of the board of directors until the first election thereof are as follows:

FIFTH:

The corporation shall have members.

SIXTH: No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustee, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statement) any political

campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

SEVENTH: The corporation will distribute its income for each tax year at such time and in such manner as not to become subject to the tax on gundistributed income imposed by Section 4942 of the Internal Revenue Code, or corresponding section of any future federal tax code.

The corporation will not engage in any act of self-dealing as defined in Section 4941(d) of the Internal Revenue Code, or corresponding section of any future federal tax code.

The corporation will not retain any excess business NINTH: holdings as defined in Section 4943(c) of the Internal Revenue Code, or corresponding section of any future federal tax code.

The corporation will not make any investments in such manner as to subject it to tax under Section 4944 of the Internal Revenue Code, or corresponding section of future federal tax code.

The corporation will not make any taxable **ELEVENTH:** expenditures as defined in Section 4945(d) of the Internal Revenue Code, or corresponding section of any future federal tax code.

TWELFTH: Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by the Circuit Court of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
