	Deeds and Mortgages, and is also the owner of the indebtedness secured by said mortgage, the amount of the principal indebtedness thereby secured being now \$ 23,059.92 : and, according to the terms and conditions of said note and any renewals and extensions thereof and wife Nellie M Walton WHEREAS the undersigned Kenneth W Walton and wife Nellie M Walton
	now the owners, subject to said debt and mortgage, of the property described in and conveyed by said mortgage, and they requested the Mortgagee to grant an extension of time of payment of said mortgage indebtedness so as to make the same payable as hereinafter set forth, and the Mortgagee has agreed to grant such extension upon the terms and conditions hereinafter stated:
	NOW, THEREFORE, in consideration of the premises and to evidence the agreement of the parties, the undersigned agree—to pay to the Mortgagee or to the successors or assigns of the Mortgagee, the said indebtedness in installments as follows:
	WHEREAS, on the 19th day of June 1989, Kenneth W Walton and wife Nellie M Walton. executed a mortgage and a promissory note to the First National Bank of Columbiana in the principal amount of \$23,961.49, which said sum was payable in 23 installments of \$312.00 and one balloon of \$22,539.68; said installments commencing on the 15th day of July, 1989. WHEREAS, 1 of said payments in the amount of \$310.00 was due on the 15th day of August, 1990 and said debtor desires to have the time of payment of said installment extended to the 15th day of June, 1991; and WHEREAS, said Bank does agree for the date for the payment of said installment to be extended as provided for above.
