Before me, Victor Bailey, the undersigned authority, personally appeared Jack Jackson, Willie Mae Datcher, and Samuel Lee Jackson, who, being first duly sworn, depose and say:

1. We are all the heirs at law of Willie Jackson (who died February 10, 1966) and Nellie H. Jackson (who died January 30, 1979).

2. Willie and Nellie H. Jackson, both of whom died without wills, had four children, who constituted their heirs at law. There was no administration of their estates. The Willie and Nellie H. Jackson homestead descended to the following heirs:

(a) John Jackson, also known as John King, Social Security Number [REDACTED], who died intestate, unmarried and without children on July 7, 1980, in Niagara Falls, New York.

(b) Jack Jackson, who is married to Alma Jackson. Alma Jackson lives, and has lived, in Chicago, Illinois, for many years. She has never lived on the Willie and Nellie Jackson home place as her homestead property;

(c) Willie Mae Datcher, a widow;

(d) Fannie Mae Jackson, deceased, died intestate and was not survived by a husband. There was no administration of her estate. Her only child is Samuel Lee Jackson, who is married, but whose spouse has never lived on the Willie and Nellie Jackson homestead as a homestead.
