Commence at the Northwest corner of Section 7, Township 20 South, Range 1 East and run South 03 degrees 30' west along the west boundary line of said Section for a distance of 2073.84 feet; thence continue along last said course a distance of 550.0 feet; thence run south 86 degrees 44' east for a distance of 1344.23 feet; thence north 01 degrees 13' east for a distance of 550.0 feet; thence run north 86 degrees 43' west for a distance of 1322.34 feet to the point of beginning; being situated in Shelby County, Alabama.

Nothing herein contained shall in anywise impair, alter or diminish the effect of the aforesaid restriction on the remaining property described in that certain deed recorded in Volume 247 at Page 253 in the Office of the Judge of Probate of Shelby County, Alabama.
