

RECIPROCAL EASEMENT AGREEMENT

THIS RECIPROCAL EASEMENT AGREEMENT is made and entered into as of the be day of January , 1990, by and between DANIEL OAK MOUNTAIN LIMITED PARTNERSHIP, an Alabama limited partnership ("Grantor"), and DANIEL LINKS LIMITED PARTNERSHIP, an Alabama limited partnership ("Grantee").

RECITALS:

Grantor and Grantee have contemporaneously herewith entered into a ground lease (the "Ground Lease") pursuant to which Grantor has leased to the Grantee certain real property situated in Shelby County, Alabama which is more particularly described in Exhibit A attached hereto and incorporated herein by reference (the "Golf Club Property"). The Ground Lease also includes a purchase option which may be exercised by Grantee, its successors and assigns, as provided for in the Ground Lease. A Memorandum of Ground Lease evidencing the Ground Lease has been executed by Grantor and Grantee and recorded in Real 312, Page 268 in the Probate Office of Shelby County, Alabama.

Grantor is the owner of certain real property situated on the eastern side of U.S. Highway 280 in Shelby County, Alabama which is more particularly described in Exhibit B attached hereto and incorporated herein by reference (the "Development") which Grantor contemplates developing for mixed residential and multi-family uses. The Development is situated

adjacent to and is contiguous with the Golf Club Property.

Grantor desires to grant to Grantee a permanent,
perpetual and nonexclusive easement over, across, through perpetual and nonexclusive easement over, across, through and upon (i) a roadway known as "Hugh Daniel Drive", which is more particularly described in Exhibit C attached hereto and incorporated herein by reference ("Hugh Daniel Drive") and (ii) that certain roadway to be constructed by Grantor upon that portion of the Development which is more particularly described in Exhibit D attached hereto and incorporated herein by reference (the "Access Easement Property").

Grantee desires to grant to Grantor a permanent, perpetual and nonexclusive easement over, across, through, under and upon those five (5) parcels of land situated on the Golf Club Property which are more particularly described in Exhibit E attached hereto and incorporated herein by reference (hereinafter collectively referred to as the "Cross-Easement Property").

NOW, THEREFORE, in consideration of the premises, the sum of Ten and No/100 Dollars (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties do hereby agree as follows:

- EASEMENT RIGHTS WITH RESPECT TO HUGH DANIEL DRIVE. Subject to the terms and conditions set forth in Paragraphs 4(b) and 4(c) below, Grantor does hereby grant, bargain, sell, convey and assign to Grantee, its successors and assigns, forever, a permanent, perpetual and nonexclusive easement over and upon, and the right to use for pedestrian and vehicular travel and transportation purposes, Hugh Daniel Drive, as described in Exhibit C hereto. The easement to and rights to use Hugh Daniel Drive granted herein by Grantor to Grantee shall be subject to and used in common with Grantor, its successors and assigns, and any other parties having any rights or interest therein.
- EASEMENT RIGHTS WITH RESPECT TO ACCESS EASEMENT PROPERTY. Subject to the terms and conditions set forth in Paragraphs 4(b), 4(c) and 6 below, Grantor does hereby grant, bargain, sell, convey and assign unto Grantee, its successors and assigns, forever, a permanent, perpetual and nonexclusive easement over, across, through and upon the Access Easement Property, as described in Exhibit D hereto, and all private roadways now or hereafter constructed within the Development intersecting or abutting the Golf Club Property, for (i) pedestrian and vehicular travel and transportation purposes, (ii) installing, erecting, maintaining, operating, repairing, replacing and relocating underground master television and/or cable systems, security systems, irrigation systems and all other utilities necessary or convenient for the use or Monodevelopment of the Golf Club Property, including, without limitation, publicly or privately owned and operated electrical, gas, telephone, water and sewer services, storm drains and sewers, drainage systems, lines, pipes, conduit, equipment, machinery and other apparatus and appurtenances, (iii) the installation, maintenance, replacement, operation and repair of golf car and pedestrian paths and crossing, including, without limitation, tunnels and culverts for golf cars and pedestrian use and (iv) the installation, erection, maintenance and operation of signage, caution signals, and the marking or striping of pavement to indicate golf car and pedestrian crossing; provided, however, that all of the foregoing shall be constructed, installed, operated and maintained in a good and workmanlike manner and condition reasonably satisfactory to Grantor and in accordance with all applicable federal, state, county and local governmental requirements, if any. Nothing contained in this Paragraph 2 shall be deemed to obligate Grantee to install any of the foregoing improvements.
 - 3. EASEMENT RIGHTS WITH RESPECT TO CROSS EASEMENT Subject to the terms and conditions set forth in PROPERTY. Paragraphs 4(b) and 4(c) below, Grantee does hereby grant, bargain, sell, convey and assign unto Grantor, its successors and assigns, forever, a permanent, perpetual and nonexclusive easement over, across, under, through and upon the Cross Easement Property, as described in Exhibit E hereto, for the purposes of (i) vehicular and pedestrian travel and transportation, including the right to construct and maintain

roadways thereon, (ii) installing, erecting, maintaining, operating, replacing and relocating underground master television and/or cable systems, security systems, irrigation systems and all other utilities necessary or convenient for the use or development of any portion of the Development, including, without limitation, publicly or privately owned and operated electrical, gas, telephone, water and sewer services, storm drains and sewers, drainage systems, lines, pipe, conduit, equipment, machinery and other apparatus and appurtenances and (iii) the installation, maintenance and repair of any roadways, traffic signage, street lights, landscaping, walkways and bicycle and jogging paths and lanes thereon; provided, however, that Grantor shall be under no obligation to install any of the foregoing described improvements on the Cross Easement Property. If any of the foregoing improvements are constructed by Grantor on the Cross Easement Property, the same shall be constructed, installed, operated maintained in a good and workmanlike manner and condition reasonably satisfactory to Grantee and in accordance with all applicable federal, state, county and local governmental requirements, if any.

4. NATURE OF EASEMENTS.

- (a) The easements granted pursuant to Paragraphs 1, 2 and 3 above shall be and are (i) appurtenant to and shall serve both the Golf Club Property and the Development, (ii) covenants running with the Golf Club Property and the Development and (iii) binding upon and shall inure to the benefit of Grantor and Grantee and their respective successors and assigns. Grantor and Grantee each hereby covenant and agree that no fences or other obstructions shall be erected, maintained or permitted on, across or upon the Access Easement Property or the Cross Easement Property; provided, however, that Grantor shall have the right to control access to any portion of the Development by installing guardhouses, gates and other security devices on any portion of the Access Easement Property. To the extent Grantor controls or limits access and use of the Access Easement Property, then Grantor shall provide to Grantee, its successors and assigns, security clearance and the continued right of access to all portions of the Access Easement Property.
 - (b) Grantee hereby covenants and agrees that should Grantor desire to dedicate as public roadways any of the roadways constructed upon either the Access Easement Property or the Cross Easement Property, then Grantee shall, at no cost or charge to Grantor, execute and deliver to Grantor any and all further instruments, documents or agreements requested by Grantor in order to cause such roadways to be dedicated as public roadways. Notwithstanding anything provided herein to the contrary, Grantor (i) does hereby establish and reserve the perpetual right, in its sole and absolute discretion, at any time and from time to time, to dedicate Hugh Daniel Drive or any portion thereof, the Access Easement Property or any portion thereof and any of the private roadways now or

hereafter constructed within the Development, including any such private roadways which may be constructed on any of the Cross Easement Property, as public roadways to any governmental authority without requirement that the approval or consent of Grantee, its successors and assigns, be obtained and (ii) shall be and hereby is, authorized and entitled to execute any and all agreements, documents, instruments and subdivision plats pursuant to which Hugh Daniel Drive or any portion thereof, the Access Easement Property or any portion thereof and any of the private roadways now or hereafter constructed within the Development, including any such private roadways which may be constructed on any of the Cross Easement Property, 'is submitted for dedication as public roadways. To the extent Grantee's execution of any such agreement, document, instrument or subdivision plat is required for the public dedication of all or any portion of Hugh Daniel Drive, the Access Easement Property or any portion thereof and any of the private roadways now or hereafter constructed within the Development, including any such private roadways which may be constructed on any of the Cross Easement Property, Grantee, for itself and its successors and assigns and their respective members, guests, shareholders, partners, officers, directors, mortgagees, lenders, creditors and transferees, does hereby irrevocably appoint Grantor as its agent and attorney-in-fact for the purpose of executing, signing, acknowledging, swearing to and recording any and all instruments, certificates, documents, agreements and subdivision plats relating to the dedication of said roadways or any portion thereof as public roadways for - and in the name of Grantee, in Grantee's name, place and The power and authority granted herein is hereby declared to be irrevocable and a power coupled with an interest which shall survive the death or dissolution of Grantee and shall be binding on Grantee, its successors and assigns and their respective members, guests, shareholders, partners, officers, directors, mortgagees, lenders, creditors and transferees, forever. The provisions of this Paragraph 4(b), including, specifically, the power of attorney contained herein, shall be binding upon Grantee, its successors, assigns, tenants and subtenants and their respective members, guests, shareholders, partners, officers, directors, mortgagees, lenders, creditors and transferees, each of whom shall be bound by the terms and provisions of this Reciprocal Easement Agreement. In the event any of the foregoing described roadways are dedicated to any governmental authority, the easements described in Paragraphs 2 and 3 above shall survive such dedication.

(c) Notwithstanding anything provided to the contrary in this Reciprocal Easement Agreement, during any golf tournaments sponsored by Grantee or by any other private golf and/or country clubs situated in close proximity with the Development which utilize any portion of Hugh Daniel Drive for access purposes, Grantor reserves the right to limit and restrict access to Hugh Daniel Drive, the Access Easement Property and all private roadways now or hereafter constructed

in the Development intersecting or abutting the Golf Club Property and, to the extent practicable, to otherwise make portions of Hugh Daniel Drive, the Access Easement Property and the private roadways within the Development, one-way roads. In connection with any golf tournaments sponsored by Grantee, its successors or assigns, on the Golf Club Property, Grantor agrees to assist Grantee, its successors and assigns, in controlling and to the extent practicable, limiting or restricting traffic on or making one-way roads of Hugh Daniel Drive, the Access Easement Property and all other private roadways now or hereafter constructed in the Development.

5. <u>USE RESTRICTIONS</u>. Grantee agrees that the Golf Club Property shall be used solely for the construction and operation of a first-class golf and country club, with related amenities, including, without limitation, clubhouses, proshops, grills, restaurants, lounges, banquet facilities, swimming pools, tennis courts, driving and practice golf ranges, maintenance and storage facilities and buildings and any other related improvements, and for no other purpose.

6. ACCESS EASEMENT ROADWAY.

- (a) Grantor agrees to construct, install and maintain in accordance with the engineering and planning department standards of the applicable governmental authorities a roadway over, across, through and upon the Access Easement Property (the "Access Roadway") in order to provide vehicular and pedestrian access to and from the Golf Club Property and Hugh Daniel Drive. Grantor shall also provide all necessary utilities, including, without limitation, electricity, gas, telephone, water, sewer and cable television, to the Golf Club Property.
- (b) Grantee agrees to pay to Grantor, as a partial deferment of the costs of maintaining the Access Roadway (including the maintenance of security guards or gates at the entrance of the Access Roadway if Grantor elects to establish the same) the following:
 - (i) Commencing on the date that the 18-hole golf course to be constructed by Grantee on the Golf Club Property is opened for play, Grantee shall pay to Grantor the sum of Fifteen Thousand and No/100 Dollars (\$15,000.00) per annum (the "Road Maintenance Rent"), subject to increase and proration as provided below.
 - (ii) The annual Road Maintenance Rent for the year in which the golf course is opened for play shall be prorated on the basis of the number of days remaining in the then calendar year in which the golf course is opened.

-

(iii) The annual Road Maintenance Rent shall be subject to annual adjustment on the first day of January of each year (commencing in January of the year immediately following the golf course opening), by multiplying the annual Road Maintenance Rent of \$15,000.00 by a fraction, the numerator of which shall be the CPI (as herein defined) for December of the immediately preceding year and the denominator of which shall be the CPI (as herein defined) for the month and year in which the golf course opened for play. As used herein, the term "CPI" shall mean the U.S. Consumer Price Index (All Urban Consumers, United States City Average, All Items, 1982-1984=100). In the event the CPI ceases to be published or no longer exists in the form specified herein, Grantor shall determine a reasonable substitute equivalent official index or use appropriate conversion factors to accomplish such substitution.

Except as provided in Paragraph 6(b)(i) above, all Road Maintenance Rent, as adjusted as provided above, shall be due and payable in advance in one lump sum on the first day of January each year. The provisions of this Paragraph 6 shall survive the exercise of the purchase option granted to Grantee by Grantor under the Ground Lease and, the Road Maintenance Rent, as adjusted as provided above, shall continue to be payable on January 1 of each year as Grantee's share of the cost of maintaining the Access Roadway and any security

- related thereto.

 (c) In Grantor's sole discretion, Grantor may transfer and convey the Access Roadway and the obligation to maintain the same to an owners association (the "Association") to be formed for the Development in which event Grantor's sobligations hereunder (including the right to receive the Road Maintenance Rent) shall be assumed by the Association and Grantor shall have no further obligation hereunder.
 - **SURVIVAL**. Grantor and Grantee hereby agree that all of the provisions of this Reciprocal Easement Agreement shall survive the exercise of the purchase option granted by Grantor to Grantee under the Ground Lease.

8. MISCELLANEOUS PROVISIONS.

(a) This Agreement constitutes the entire agreement between the parties hereto and may be amended or modified only upon the written consent of the record title owners of the Golf Club Property and either (i) Grantor until such time as Grantor has transferred the rights and obligations regarding the Access Roadway pursuant to Paragraph 6(c) above or (ii) the Association for the Development if Grantor has transferred such rights and obligations.

- (b) The paragraph headings and captions used herein are for convenience of reference only and shall in no way define, limit or describe the scope or intent of this Agreement or in any way affect the terms and provisions hereof.
- (c) Whenever the context so requires, the use of the masculine gender shall be deemed to include the feminine, the singular shall include the plural and vice versa.
 - (d) This Agreement shall be binding upon and inure to the benefit of the parties hereto and their respective successors and assigns.
- (e) The terms "Grantor" and "Grantee" as used herein shall include the parties hereto and their respective successors, assigns, tenants, subtenants, members, guests, shareholders, partners, officers, directors, mortgagees, lenders, transferees, agents, employees and invitees.

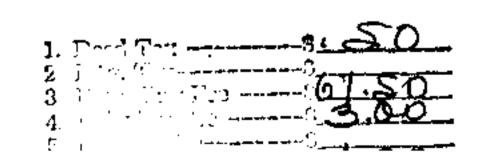
