Before me, the undersigned authority, a Notary Public in and for said County, in said State, personally appeared SUE ASH WOODRUFF, who is known to me, and who, being by me first duly sworn, on oath deposes and says as follows:

I live at 515 Fourth Street North, Birmingham, Alabama and I am over the age of twenty-one years.

My grandmother, SUSAN ASH, died intestate in Montevallo, Alabama in approximately the year 1946 owning Lots 38 and 39, Block No. E, Ellis Addition to Montevallo, situated in Shelby County, Alabama. On the date of her death SUSAN ASH was a widow, her husband RYLAND ASH, who was my grandfather, having predeceased her. There was only one child ever born to my said grandfather and grandmother and that child was my father, ROBERT WESLEY ASH. There were never any other children born to my grandfather or grandmother and, therefore, the said, ROBERT WESLEY ASH, constitutes the sole heir at law and next of kin of my grandmother, SUSAN ASH, deceased.

My grandmother, Susan Ashe, died intestate in Montevallo, Shelby County, Alabama in about the year 1930 owning Lots 38 and 39, Block "E", Ellis Addition to Montevallo, Shelby County, Alabama, my grandfather, Ryland Ashe, having predeceased my grandmother.
