KNOW BY ALL MEN BY THESE PRESENTS THAT: Whereas the undersigned parties are owners of all the property abutting, or in any way served by the property herein described, and own all of the lands abutting on or touching said property, and as such owners are desirous of vacating all the property herein described, as provided by the Statutes of Alabama, particularly Section 23-4-1 et. seq., Code of Alabama (1975).

NOW THEREFORE, the undersigned parties, being the owners of all the lands abutting on the following described property.

A road approximately four miles in length, commencing at its intersection with County Highway 260 in the SW-1/4 of the NW-1/4 of Section 17, Township 21 South, Range 3 West and travels in a southward direction through Sections 17, 18, 19, 20, 30, and 31 where it ends at its intersection with Shelby County Highway 22 in the NW-1/4 of the SE-1/4 of Section 31, Township 21 South, Range 3 West. 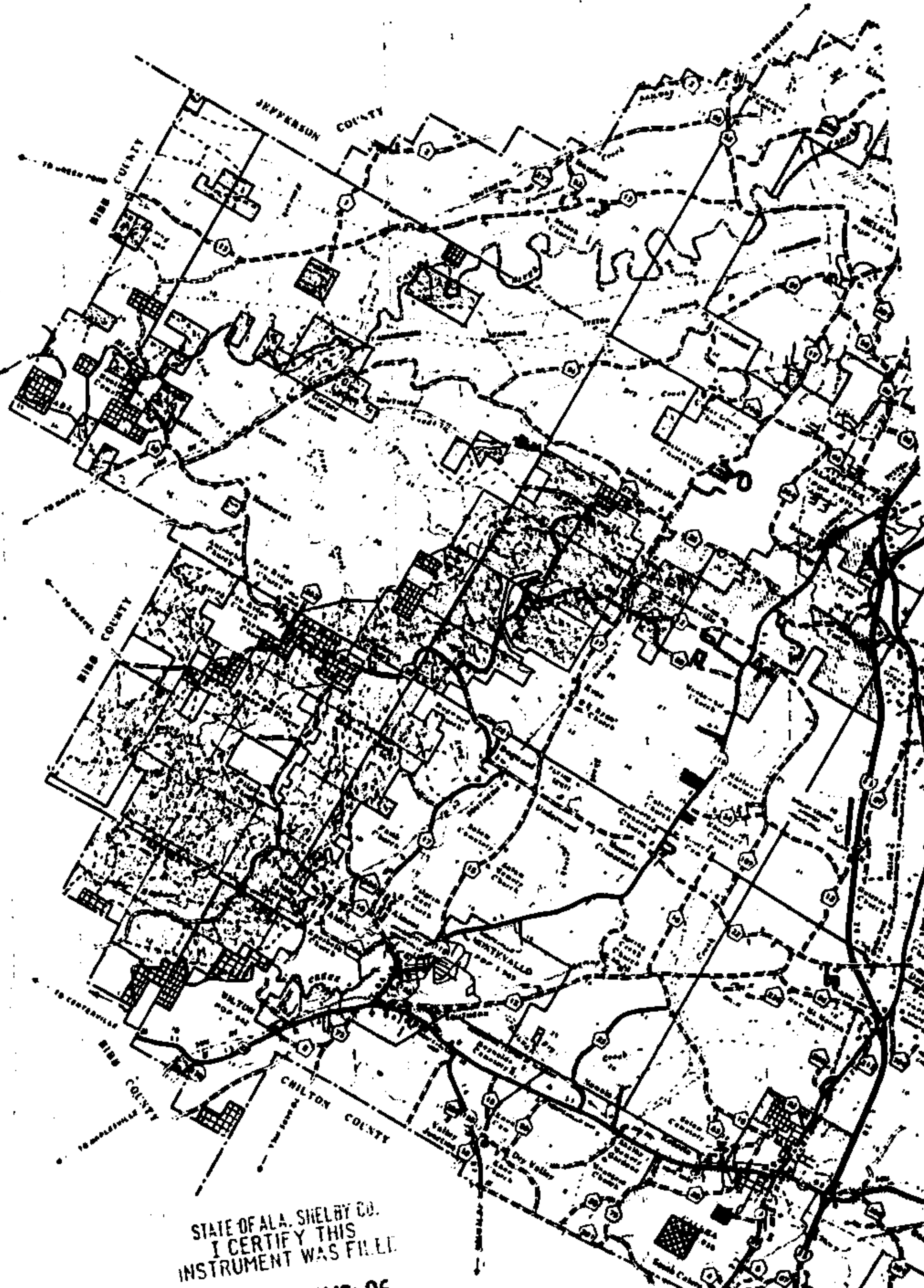
