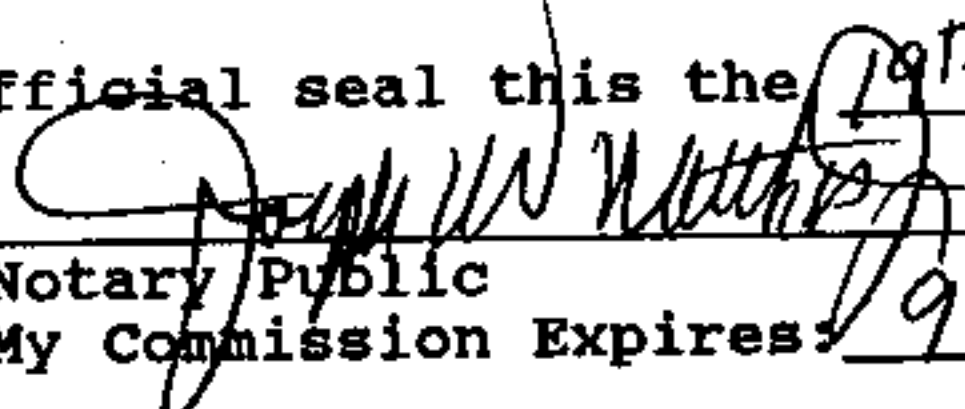

Part of the NE $\frac{1}{4}$ of the SE $\frac{1}{4}$ of Section 21, Township 20 South, Range 3 West, Shelby County, Alabama, being more particularly described as follows:

From the northwest corner of said $\frac{1}{4}$ - $\frac{1}{4}$ section, run in an easterly direction along the north line of said $\frac{1}{4}$ - $\frac{1}{4}$ section for a distance of 22.26 feet, more or less, to an existing iron pin being the northwest corner of that certain parcel of land owned by Brookline, An Alabama General Partnership, being the point of beginning; thence continue along last mentioned course for a distance of 690.00 feet; thence turn an angle to the right of 90° and run in a southerly direction for a distance of 1,225.00 feet; thence turn an angle to the right of 90° and run in a westerly direction for a distance of 689.00 feet, more or less, to a point on the east right-of-way line of Shelby County Highway #17; thence turn an angle to the right and run in a northerly direction along said east right-of-way line for a distance of 1,140.62 feet to an existing iron pin; thence turn an angle to the right of 11° 31' 11" and run in a northeasterly direction for a distance of 89.42 feet, more or less, to the point of beginning, LESS AND EXCEPT any part of the above description lying in the NW $\frac{1}{4}$ of SE $\frac{1}{4}$ of said section.

The following is a description of a parcel of land situated in the NE $\frac{1}{4}$ of the SE $\frac{1}{4}$ of Section 21, Township 20 South, Range 3 West, Shelby County, Alabama, being more particularly described as follows: From the Northwest corner of the NE $\frac{1}{4}$ of the SE $\frac{1}{4}$ of Section 21, Township 20 South, Range 3 West, Shelby County, Alabama, run East along the North line of said NE $\frac{1}{4}$ of SE $\frac{1}{4}$ for a distance of 22.26 feet, more or less, to an existing iron pin on the East right of way line of Shelby County Road No. 17, said existing iron pin also being the point of beginning; thence continue along last mentioned course for a distance of 577.85 feet; thence turn an angle to the right of 90 deg. and run in a southerly direction for a distance of 300 feet; thence turn an angle to the right of 90 deg. and run in a westerly direction for a distance of 554.66 feet to the beginning of a curve to the right, said curve having a central angle of 86 deg. 39 min. 53 sec. and a radius of 25 feet; thence turn an angle to the right and run along the arc of said curve for a distance of 37.81 feet to a point on the East right of way line of Shelby County Road No. 17, said point also being the end of said curve; thence run in a northerly direction along said East right of way line of Shelby County Road No. 17 for a distance of 188.26 feet; thence turn an angle to the right of 11 deg. 31 min. 11 sec. and run in a northeasterly direction for a distance of 89.42 feet to the point of beginning; being situated in Shelby County, Alabama.
